Sir,

I, ASI Debasish Das of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Niki Das (20 yrs) S/O Late Jagannath Das of Diesel Colony, Thakkar, PS- Prodhan Nagar, Dist- Darjeeling, (2) Mostafa Mia (22 yrs) S/O Tahar Mia of Paschim Binsnoy, PO- Bava Matabari, PS-Dinhata, Dist- Cooch Behar, A/P Matangini-I, Tikiapara, PS- Siliguri, Dist- Darjeeling, (3) Bubai Das (31 yrs) S/O Tarun Das of Shantinagar Bow Bazar near Shantinagar Sporting Club, Ward No.36, PS- Bhaktingar, Dist- Jalpaiguri, (4) Totan Mandal (35 yrs) S/O Late Sudhir Mandal of Dakkhin Santingar near Adarsha Mandir, Houshing Complex, Jabravita , PS- NJP, Dist- Jalpaiguri under arrest along with following seizure articles; (i) One (01) knife measuring 09" (Approx) inches including Plastik handle recovered from the possession of Niki Das (knife was on his hand) (ii) One (01) Iron Made Rod with Curb measuring 23" (Approx) inches recovered from the possession of Mostafa Mia (seemed to be implement of house breaking) it was on his hand (iii) One Nylon Rope measuring approx 16 Fit recovered from Bubai Das and (iv) One (01) Iron Made Rod with Curb measuring 23.5" (Approx) inches recovered from the possession of Totan Mandal (seemed to be implement of house breaking) was on his hand In this regard, I beg to report that on 11.01.2025 at 01:05 hrs received secret reliable source information that about 10/12 anti-socials being armed with deadly weapons assembled at Back side of Indoor Stadium, Deshbandhupara under Siliguri PS for making preparation to commit dacoity in a house at Deshbandhupara area under Siliguri PS. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No.788 Dated. 11.01.2025. As per the direction of IC Siliguri PS, at 01.15 hrs, I along with ASI Rabin Lama, ASI Subir Sen, ASI Mahasagar Barma , C/334 Biswanath Barman, C/1466 Parimal Das and C/160 Soumen Sarkar along with investigation Kids left for Back side of Indoor Stadium, Deshbandhupara under Siliguri PS for working out the information vide Siliguri GDENo.789 dated 11.01.2025 after briefing officers and force properly. At 01.25 around hrs we reached at near Back side of Indoor Stadium, Deshbandhupara under Siliguri PS and kept our vehicle at considerable distance near Back side of Indoor Stadium, Deshbandhupara under Siliguri PS. Then, I along with other Officers and force headed towards Back side of Indoor Stadium, Deshbandhupara under Siliguri PS looking for witnesses, if any on the way and found nothing. By this time we reached at Back side of Indoor Stadium, Deshbandhupara under Siliguri PS PS, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted four persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 06/07 others assembled at the spot making preparation to commit dacoity tonight in a house at Desbandhupara area under Siliguri PS. I accordingly searched them in presence of witnesses and found; (i) One (01) knife measuring approx. 09" (Approx) inches including Plastik handle recovered from the

possession of Niki Das (knife was on his hand) (ii) One (01) Iron Made Rod with Curb measuring approx. 23" (Approx) inches recovered from the possession of Mostafa Mia (seemed to be implement of house breaking) was on his hand (面) One Nylon Rope measuring approx. 16 Fit recovered from Bubai Das and (iv) One (01) Iron Made Rod with Curb measuring approx. 23.5" (Approx) inches recovered from the possession of Totan Mandal (seemed to be implement of house breaking) was on his hand were making preparation for committing Dacoity tonight in a house at Desbandhupara area under Siliguri PS but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of above mentioned witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 01.45 hrs and 02.45 hrs dated 11.01.25. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at Desbandhupara area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at Deshabndhupara area. I

Further, it to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons & others 06/07 others who fled away, under proper section of law and to cause its investigation.
