Pradhan Nagar, Dist. Darjeeling and residing at Sastri Nagar, Iskcon Road, P.S. Bhakti Nagar, Dist. Jalpaiguri since last few months.**

I, Miss Aman Kaur (age 38 years), Daughter of Late Guru Charan Singh Lamba, beg to lodge this complaint to the effect that the harassment / assault both mentally and physically is being faced by me by Mr. Asish Majumder, who is a stranger, presently working at our hotel at "Shere Punjab Hotel and Restaurant" situated at P.O. & P.S. Pradhan Nagar.

The said Asish Majumder's intention is to capture my hotel property and house property by any means.

The said Asish Majumder, (Phone No- 9831118904) basically came from Kolkata and presently residing at Sastri Nagar, Iskcon Mandir Road, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri and working in our Hotel at Shere Punjab Hotel, Pradhan Nagar. On 1<sup>st</sup> day of January,



2025 at about 1:30 AM, midnight, entered into our house at Lamba Niwas, Sai Mandir Road, in Ward No.3 of Siliguri Municipal Corporation, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, forcefully and tried to threaten me physically and mentally and also threatened me with dire consequences. Firstly he tried to punch me on my face several times and thereafter he pushed me and threatened to kill me. It is a matter of deep concern from me. Sir I am a helpless lady and by seeing the interference of said Asish Majumder into our family, hotel and house is dangerous for me and I am feeling insecure into my own home due to him.

I therefore humbly request you Sir/ Madam to kindly enquire into the matter and take necessary action against said Asish Majumder who has harassed me by punching me on my face and body and also to kill me.
