The accused persons used abusive language, threatened us that they will mentally torture targetting only the heart patients of my family to teach us a lesson. The same thing they did on 09th January night at around 11pm, disrupted the peace of my family. They even threatened physical harm & damage to property, and caused immense mental torture, which has worsened my families health condition. All of the patients of my family had suffered drastic health deterioration after the quarrel. We are in trauma and they have openly declared that they will play the *Women Card* to victimise our family. (Criminal Conspiracy to fabricate Rape Case against male members of my family)

Along with filthy languages all four of them have disrupted our mental peace, my children are in trauma.

I severely felt intimidated , harassed fearful for my safety as well as my bedridden family members , taking surgical rest after heart surgery.

I request that necessary action be taken against the accused persons under proper sections of Law.
