I, SI Rickey Tamang of Special Task Force, WB, Siliguri Unit do hereby lodge this complaint against the above noted accused person to the effect that on 11.01.2025 at about 17:55 hrs I received a credible source information that one Md. Sartaz Alam @ Ali Bhai (42 years) s/o Md Ajij of Dangipara, Ward No. 06, PO & PS Siliguri, Dist Darjeeling is possessing huge quantity of Cocaine contraband drug in his house which he has been selling to some drug addicted persons in Siliguri town area. It is also learnt that

he may leave his house after some time to sell the said Cocaine contraband drugs clandestinely and immediate action is required to prevent his escape and disposal of drugs. I have reduced this information in General Diary of STF Office, Siliguri vide GDE No. 83 dated 11.01.25 and verified the genuineness of this information and it appears to be genuine. I have brought this information to the knowledge of my superior Dy.SP Debdatta Banerjee in writing, who directed and authorised me to work out the information after forming a team. As the information was received after sun set, as per provision of Section 42 of NDPS Act, it is necessary to obtain Search Warrant but the search warrant could not be obtained quickly due to odd hours and hence there was every chance of dispatch of the contraband drug from his house to unknown destination for clandestine sale if raid was not organized immediately.

Thereafter, I have formed a raid team consisting myself along with Insp. Praveen Pradhan, Insp. Joydev Ghosh, SI Raju Subba and ASI Ajimul Haque and obtained a written permission to work out the information with the said team. Thereafter, at 17:50 hrs myself along with officers and force left STF Siliguri office vide GDE No. 84 dated 11.01.25. I also took with me investigation Kit Box containing metal seal of STF WB & rubber stamps, Sealing wax, candles, match box, stamp pad, pin box, cello tape, threads, different type envelopes, electronic weighing machine, official laptop, UPS, portable printer, extension cord, camera, charger lights, Field Testing Narcotic Kit, one new Simmtronics 32 GB memory chip etc. and we availed vehicle WB16BC6361.

At about 18:15 I arrived at Siliguri PS and submitted a requisition to the IC Siliguri PS for providing local police assistance for conducting search, raid and seizure. Thereafter, at about 19:45 hrs we along Siliguri PS police team proceeded to Dangipara, Ward No. 6. After reaching Dangipara my source identified to me the house of the suspect Sartaz Alam @ Ali Bhai. We tried to call local witnesses but only one local witness named Nazre Alam could be found who was residing in the same building who volunteered to stand witness to the entire process of search and seizure.

At 21:45 Hrs we held raid in the house of the suspect Sartaz Alam @ Ali Bhai and apprehended him. We disclosed our identity to him showing our departmental identity cards. On being asked he disclosed his name and address as noted above. I briefed him about the information in hand, but he denied to the allegation and kept misleading the raid team. After prolonged interrogation for a long time he finally confessed to be in possession of Contraband Drug Cocaine which he had kept concealed in a secret place. I then informed the development to Dy.SP Debdatta Banerjee who told me to detain the above noted person and immediately arrived at the spot i.e at the house of Sartaz Alam @ Ali Bhai at house no 303 Dangipara where Dy.SP Debdatta informed that Inspector Tshewang Norbu would stand as Gazatted officer to the search and seizure process. I introduced them to the detained accused person and as well as the witness. Inspector Tshewang Norbu Lama examined the detained person and the offered search of the entire raid team and the witnesses to the detained person and also served notice w/s 103 BNSS to the entire raid team and the witnesses to the detained person and belonging he has the right to accused person and explained that prior to the search of his person and belonging the legality search all the police personnel. He received the notice u/s 103 BNSS and after understanding the legality

he gave consent in writing that he does not wish to search the police personnel. But I requested him to search us and accordingly he searched us and no contraband could be found with us and I prepared a Nil seizure list and the accused along with all police personnel put their signatures with date in the Nil seizure list.

Thereafter, in presence of Dy.SP Debdata Banerjee and Inspector Tshewang Norbu Lama I started search process. The accused led us to his bedroom and took out one white synthetic packet which was concealed under the mattress of his bed. On opening the said white synthetic packet it was found that it contained (1) one transparent zip lock plastic pouch containing 32 (thirty two) small packets of white plastic wrapped with rubber band each containing white powder suspected to be Cocaine and (2) one transparent zip lock plastic pouch containing 23 (twenty three) small packets of white plastic ball shaped packets with knots each containing white powder suspected to be Cocaine. (3) One transparent Zip lock plastic pouch containing 50 pieces of small sized white transparent Zip lock plastic pouch (4) One small sized steel spoon (5) One Silver colored small digital weighing machine fitted with two pencil batteries (6) One white colored synthetic bag and (7) One plastic packet containing small multi colored rubber bands.

I then took a small quantity of white powder randomly from both the transparent plastic packets and tested them through narcotic drug field testing kit using required reagent and the colour appeared positive for the presence of Cocaine.

Thereafter, with the help of electronic weighing machine I weighed the packets. (1) The transparent zip lock plastic pouch containing 32 (thirty two) small packets of white plastic wrapped with rubber band each containing white powder suspected to be Cocaine gross weighed 40.45 grams, marked it as Exhibit – A and (2) transparent zip lock plastic pouch containing 23 (twenty three) small packets of white plastic ball shaped packets with knots each containing white powder suspected to be Cocaine gross weighed 53.15 grams, marked it as Exhibit-B. Total gross weight = 93.60 grams.

On demand the accused produced his 02 (two) mobile handsets, Andhar Card and voter card. Thereafter, I prepared a seizure list in presence of witnesses and seized the following articles.

- (i) One transparent Zip lock plastic pouch containing 32 (Thirty two) small packets of white plastic wrapped with rubber band each containing white powder suspected and tested to be Cocnine, gross weight 40.45 grams marked as "Exhibit-A"
- (ii) One transparent Zip lock plastic pouch containing 23 (Twenty three) small packets of white plastic ball shaped packets with knots each containing white powder suspected and tested to be Cocaine, gross weight 53.15 grams marked as "Exhibit-B" (Total Gross Weight= 93.60 Grams.
- (iii) One transparent ZIp lock plastic pouch containing 50 pieces of small sized white transparent Zip lock plastic pouch marked as "Exhibit-C"

Thus, a reasonable belief having been formed that an offence has been committed in contravention of section 8C read with section 21(b)/29 of NDPS Act, 1985 and that the recovered white colored dry substance are liable to be confiscated U/S 60 and 61 of NDPS Act 1985 (as amended), the entire contraband white colored dry substance believed to be Cocaine seized U/S 43 of NDPS Act 1985 (as amended) under proper seizure list. The above mentioned detained person, witnesses, raid party put their dated signatures in the seizure list. A copy of the seizure list was given to the detained person. All the seized articles have been properly packed sealed and labelled. The detainee, witnesses and police personnel and GO put their signature in all the label. I have taken a specimen seal impression of the Metal Seal which has been used for the propose of Wax sealing. The above mentioned detained person, witnesses, G.O raid party put their dated signatures in the seizure list. I prepared a inventory list and above mentioned detained person, witnesses, G.O raid party put their dated signatures in the Inventory List.

In compliance to the order from the Honourable High Court Calcutta Video recording of the search and seizure process were due by ASI Ajimul Haque of STF, WB Siliguri with the help of the Office issued Mobile Phone and the video files are kept in a 32 GB memory card which is being deposited at PS along with this written complaint. The entire process of search, Seizure, Seal label, inventory was supervised by Shri. Debdatta Banerjee, Dy.SP STF, WB. A certificate U/S 63 (4)(C) BSA have been taken in respect of Videography of search and seizure process done by ASI Ajimul Haque of STF, WB Siliguri unit.

I then arrested the detained person Md. Sartaz Alam @ Ali Bhai (42 years) s/o Md Ajij of Dangipara, Ward No. 06, PO & P.S Siliguri, Dist.Darjeeling after maintaining all the formalities of arrest and communicating him the ground of his arrest, issued arrest of memo to him.

On further being asked the arrested accused person has stated that he had procured the contraband from one Pasang Moktan S/O Dawa Lama Moktan who is presently residing in Salbari. There are other persons also who are involved with him in this crime.

Under the above noted facts and circumstances, I pray before you that a specific case U/S 21(b)/29 of NDPS Act. May kindly be started against namely (i) Md. Sartaz Alam @ Ali Bhai (42 years) s/o Md Ajij of Dangipara, Ward No. 06, PO & P.S Siliguri, Dist. Darjeeling (ii) Pasang Moktan S/O Dawa Lama Moktan who is presently residing in Salbari and others involved in this racket for possessing huge quantity of Contraband illegally and running illegal business of Cocaine and arrange for its regular investigation.
