Dear Sir,

I, Sri Debraj Ghosh, Son of Sri Swaraj Kumar Ghosh, Proprietor of Ila Ply and Timber Trader', having its place of business at Paresh Nagar, Mini Market, 2nd Mile, Sevoke Road, Siliguri, West Bengal - 734001, engaged as timber dealer, wooden wall panel (especially the brand 'Century Ply') and laminate dealer in Siliguri, West Bengal, would like to inform you that in the month of April, 2024, one Najrul Islam, C/o Md Idris Sah, proprietor of Ayat Interior Designing Studio, engaged as Interior & Exterior Designer in Siliguri, having his office at 1st Floor, Saukat Ashfree Manzil, Iskon Mandir, By Lane, Near Hans Bela Ashram, Shastri Nagar, P.S.- Bhaktinagar, Siliguri, West Bengal-734001, also available at C/o Manab Sansar, Uttar Latabari CT, Hamiltonganj Bazar, Dakshin Latabari, Jalpaiguri West Bengal-73521, Contact No. 7679741554/9332117538/7719134885 approached me in my office and showed his eagerness to purchase ply and other interior products/items from my client on credit basis. The aforesaid Najrul Islam further assured me that he was a businessman of repute and has goodwill to maintain and thus there would be no payment issues. That accordingly, believing on his promise and assurance to pay I supplied the required goods on credit as per his requirement and he received the same with satisfaction and assured me that he would clear all the payments of the same. That for a long period of time a huge amount of goods were sold by me to the said Najrul Islam, however, a huge outstanding of Rs.8,03,377/- (Rupees Eight Lakhs three thousand three hundred seventy) only accrued on the basis of the aforesaid business transaction. That thereafter on various occasions I requested him to make the payment of the outstanding dues but he out rightly avoided and neglected to pay the same with a malafide intention to misappropriate the same. On numerous occasions I tried to contact him over telephone and whatsapp regarding my rightful claim for the payment but he kept delaying the matter on one pretext or the other thereby confirming my claim and also the fact that he had the very intention to cheat me. I had supplied and entrusted the said Najrul Islam with the goods with an expectation that he would pay the entire amount after taking the delivery as promised by him but after taking delivery of the said goods, he did not paid

the dues. It is quite evident from his conduct and gestures that he had a preconceived malafide intention to deceive me and his representation about his goodwill was nothing but misrepresentations made with the sole motive of cheating me. The above mentioned default shows ill /malafide intentions leading to deceiving me and cheating me of my legal dues for his own unlawful gain and profit. That finding no other alternative I even visited his office at the aforesaid address and to my utter shock and surprise, I found his office as well as his residential flat which is also located in the same building under lock and key. In the meanwhile I also discovered that the said Najrul Islam has also duped a lot of people including his own staff member.

I therefore, request you to kindly investigate the matter and book the culprit Najrul Islam, C/o Md Idris Sah, proprietor of Ayat Interior Designing Studio, having his office at 1st Floor, Saukat Ashfree Manzil, Iskon Mandir, By Lane, Near Hans Bela Ashram, Shastri Nagar, P.S.- Bhaktinagar, Siliguri, West Bengal-734001, also available at C/o Manab Sansar, Uttar Latabari CT, Hamiltonganj Bazar, Dakshin Latabari, Jalpaiguri West Bengal-73521, in accordance with appropriate provisions of criminal law.
