state as follows:

- ① That a Title Suit being No. 666/23 is pending before the Lt. Civil Judge Junior Division Court-1 at Jalpaiguri, against the defendant namely Ashok K. Goyal, Manju Goyal 870 Ashok K. Goyal who is a resident of Pranavi Nandi Road,
- ② That the Lt. Court was pleased to grant a Status-quo order which was later made permanent till the disposal of the case,
- ③ That as per the order of the Lt. Court the petitioner as well as the defendants are not allowed to enter the disputed property and create any third party interest.

④ That the details of the disputed property is:

⑤ That even after the order of the Court the said defendant namely Ashoke K. Goyal has been illegally entering into the disputed property with labourers and making constructions.

⑥ That when I went to stop them from entering the property the said Ashoke K. Goyal and his wife Manju Goyal threatened me of dire consequences and also threatened to kill me.

I therefore request you to take immediate action.
