Subject: Atrocities on tribals by Jain Developers Projects Pvt. Ltd. causing
repeated obstruction to lawful owner of tribal land from ingress
& egress in one's own land by erecting a wall in access common road.

Respected Sir,

I, Dr. Rebekah Subba, W/o Stephen Subba, the lawful owner of 5-katha land
having khatian no. 2165, Plot no. 455 (RS 179) Jk no. 83, Mouza Dhaknikata, P & PS
Pradhanagar, Dagapur, 734003, Siliguri.

I hold all the valid documents of ownership of land viz. Chain Deeds, Sale Deed
Mutation Certificate, Conversion Certificate, LD/SD Court Searching, BL/LRO Search reports,
Receipt of land registration tax, Panchayat Tax (Dhunikar), Electricity bills.

I would like to bring your kind attention that I was fencing my property on 05/03/24,
People representing Jain Group Projects Pvt. Ltd came and stopped our work. Thereafter
we lodged a complaint to your office vide PDNPS GDE No. 343 dated 06/03/2024
Thereafter in relation to the same matter following cases are pending before
respective Courts/Magistrates

1. File no 811/2024 dated 26.09.2024, Title Declaration Suit before Civil Judge.
(Sr. Division), Siliguri Dayceling.
2. Petition case no. 15/2024 before Id. Special Executive Magistrate.

While these cases are still ongoing, ~~today~~ on 07/01/2025, mob led by Md. Jaan-ak
consisting 10-15 people forcefully came and erected a iron gate and concrete
wall blocking the only pathway used for ingress and egress to my land. Later
I found that these people are from Jain Developers Projects Pvt. Ltd and took
such atrocious with intention to encroach the tribal lands inside.

I therefore request that your good self be kind enough to take this
matter for information and actions so as to safeguard my right and interest
in my land as member of Tribal community and law abiding citizen of India.
