I, ASI Rabin Lama of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Manish Sarkar(28 yrs/M) S/O Late Neta Sarkar of Lichubagan, Subhashpally, Bagrakot, Ward No. 18, PS- Siliguri, Dist- Darjeeling to the effect that on 16.01.25 at 09.35 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally at shop situated at Subash Pally, Bagrakot under Siliguri PS in order to clandestinely dispose the same. near local Bus stand Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1045 dated 16.01.25 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Joydeep Dutta, ASI Debasish Das, C/160 Soumen Sarkar both of Siliguri PS left for under Siliguri PS to verify the veracity of the Bagrakot near Bagrakot Bus stand information vide Siliguri PS G.D.E No.1046 dated 16.01.25. On reaching at 10.05 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up Country Spirit to locality without any valid documents. On being asked he could not produce any valid documents in respect of the said liquor. On searching i) 51 (fifty one) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 160 each (Amounting of Rs 160/- x 51 =RS.8160/-) in which one sealed bottle has taken out from mother packet box as sample and

accordingly I seized the same as per seizure list as per seizure list in which was kept concealed in his shop under Siliguri PS as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 10.28 hrs and 10.42 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts' of rules.
