Some times my father and mother also residing here. Our husband also beaten by Sanjeev Saha and so many people are their whom I don't know. From last 3 three years they trying to asking ransom money for staying here. I am so afraid and life fear from them. They always came and tortured mentally, and physically with threat that they will do some harmful to us.

I am here to lodge a complaint against them of IPC-499,341,323 and 354.
