**Subject:** Complaint regarding continuous nuisance and illegal obstruction by accused persons

I, the undersigned, Dilip Agarwal, along with my brother Dinesh Agarwal, am the co-owner of the below-mentioned scheduled land under the partnership firm *Greenwood Constructions*. We have been in peaceful and uninterrupted possession of the said land for more than 35 years.

On the morning of 15.01.2025, at approximately 11 am Sri Sadhan Oraon, Sri Madan Oraon, Sri Harilal Oraon, Sri Sabulal Panna along with other unidentified individuals, arrived at the entrance of our property. They caused a public nuisance and attempted to obstruct workers engaged in cleaning activities on our land.

These individuals falsely alleged that a court order prohibited us from using or working on the land. However, to the best of our knowledge, no such court order exists, and no legal restrictions have been placed on our lawful use of the scheduled land.

Furthermore, their actions today are not isolated. They have a history of lodging baseless complaints against us in various forums, all of which have been dismissed in our favor. We apprehend that these repeated disturbances and false claims are deliberate attempts to harass us, damage our reputation, and obstruct our lawful activities.

We also fear that these individuals may escalate their disruptive behavior and potentially cause physical harm to us, our workers, or our property.
