Dear Sir,

I, Sh. Ved Prakash, Sr. Manager of Punjab National Bank, Fulbari Branch, Fulbari Hat, Fulbari, District-Jalpaiguri, would like to formally report you that, today i.e. on 13-01-2025 when I entered our branch premises at about 09:20 AM (Approx.), I found that documents of our Branch were scattered. After this we have found that our Branch's back entrance collapsible gate was broken and lock was broken. Then we have found that some items were missing from their places. Then we checked our CCTV footage and found that, on 10-01-2025 at about 11:40 PM (Friday) two unknown persons entered in from back side of branch whose faces were covered and stole different items from branch. This whole incident went on till 02:30 AM of 11-01-2025 (Saturday) as could be seen in the CCTV footage.
