Respected sir,

I, Indrajeet Saha, S/O Gopal Saha,  
Resident of Bankim Nagar, Ward no. 41, Sevoke Road  
Siliguri, 734001, have a friend Prantik Roy,  
S/O Prashanta Roy, Resident of Shibram Palli  
Bazar, Haider Para, Ward no. 39. who gave me  
credit of 12000 using an online app Kredit Bee  
with an interest of 2173 rs per month from  
November 24 to January 25. The total amount  
is now 13038 rs. But after the payment of Novem-  
ber I failed to give him the amount, so I told him  
I would give him the total amount by end of  
January. But he started to disturb me and  
my family members. He even came to my home  
and disturbed my mother who is a paralyzed dialy-  
-sis patient till 20'clock at night. The next day on  
28 december he took my phone as an interest. He  
kept on disturbing me and harass me on the stre-  
-et whenever he found me. Last night he took me  
to his mom and started questioning me, and dema-  
-nded the money. But already my aunt promis-  
-ed him to give 5000 rs by end of this week  
and rest by february 10th. So I called my  
father to settle the issue, even though he was  
out of the town, he told me to give it after

coming home. Then he called a mutual friend  
Mayukh Das, Resident of Central Chayan Para, Ward  
no. 88, and both of them started to manhan-  
dle me in front of his parents and other friends.  
They punched me several times, cut my hair,  
threatened to kill, and tore my shirt. After  
that 4 of my friends saved me and stopped  
them to beat me any further.

So, I beg to state that please  
help me in this matter, so that they donot  
harasse me any further. I would give his money  
back within a few weeks, and I request you  
to ask him to give me ~~his~~ my phone back, so  
that I can contact my people and settle this  
issue permanently.
