Respected Sir,

In producing herewith one Truck vehicle loaded with River Bed materials/Sands having Registration No- WB73B/8505 under seizure in c/w above noted case.

I beg to report that, I ASI Amal Chandra Barman of Bhakti Nagar Police station under Siliguri Police Commissionerate lodge a written complaint against the above noted vehicle to the effect that today i.e.17.01.25 at around 06.15 hrs as per source information myself along with C/953 Himanshu Barman and C/410 Mantosh Singh all of Bhakti Nagar PS had been to Prakashnagar Mahananda River bed under Bhaktinagar PS (vide Bhaktinagar PS GDE No-918 dated 17.01.25) and after reaching at 06.45 hrs, found above noted vehicle was loading sand materials from Prakashnagar Mahananda River bed under Bhaktinagar PS. On chasing the driver of the vehicle and his assistant eloped from the spot to evade police arrest. On checking the vehicle, found loaded with sand materials. Further, hence there was reason to believe that the driver of above noted vehicle and his assistant connivance with the owner of the vehicle No. WB73B/8505 had procured the loaded sand illegally and dishonestly transporting the same for their illegal gain from Prakashnagar Mahananda River under Bhakti Nagar PS

On further grilling, I enquired the local people at the spot but none could answer about the said Truck bearing No. WB73B/8505 and they procured the river bed materials, sand illegally from Prakashnagar Mahananda River bed and carrying/transporting the same to Salugara side from river bed for his wrongful gain without any valid document. Under the circumstances, to avoid any untoward incident and law and order situation, I brought the vehicle to Bhakti Nagar PS and subsequently, I seized the above noted vehicle along with loaded sand under proper seizure list in presence of local witnesses. The whole process of search, seizure took place in between 07.30 hrs to 07.50 hrs with properly audio & Videography.

Under the above, I pray before your kind end to start a case against the driver, owner of the Vehicle bearing No. WB73B/8505 and others under proper section of law and caused its investigation.
