With due respect I, SRI. BHAGWAN GOYAL, son of Late Rameswar Lal Goyal, resident of- Seth Srilal Market, P.O. and P.S. Siliguri, District- Darjeeling, PIN-734001 and communication address C/o. Anand Tyres, Hill Cart Road, Siliguri-734001, P.O. and P.S. Siliguri, District- Darjeeling, would like to inform you that me and my wife Smt. Sudha Devi Goyal purchased a plot of land measuring 5.51 Acres, appertaining to R.S. Plot No. 98, 101 and 102 recorded in R.S. Khatian No. 15, under Mouza- Baniakhari, J.L. No. 55, Pargana- Patharghata, P.O. and P.S. Matigara from one Bigu Munda, son of- Late Parmeshwar Munda, residing at- Village Baniakhari, P.O. and P.S.- Matigara, District- Darjeeling, PIN- 734010, against total consideration of Rs. 55,10,000/- (Rupees Fifty-five Lakhs and ten thousand only), by virtue of Deed of Conveyance dated 31.05.2007 being No. 8035 for the year 2012 registered in the office of the A.D.S.R., Siliguri- II at Bagdogra, after obtaining necessary permission from the Project Officer-cum-District Welfare Officer, Backward Classes Welfare Department, Siliguri, Darjeeling (Revenue Officer under Chapter-IIA of the West Bengal Land Reforms Act, 1955) at Backward Class Welfare Department, Shiv Mandir, P.O. Kadamtala, P.S. Matigara, District- Darjeeling, PIN-734011, under section 14 C of the W.B.L.R. Act, 1955.

It is to mention here that the father of said Bigu Munda, i.e. Parameshwar Munda, son of Chhuiya Oraon was the recorded owner of aforesaid land and the same was recorded in R.S. Khatian No. 15 which was finally published on 24.08.1955 as per the provisions of WBEA Act, 1953, Subsequently, the said land was recorded in L.R. Khatian No. 34 in the name of his father Parameshwar Munda, son of Chhuiya Oraon, in L.R. Plot No. 326, 342 and 343 corresponding to the aforesaid R.S. Plot numbers and after his death, the aforementioned land measuring 5.51

Acre was transferred/recorded in the name of Bigu Munda in L.R. Khatian No. 38 under Mouza- Baniakhari.

Since the date of purchase of the aforesaid land, I and my wife are in actual, khas and physical possession of the aforesaid land and we were enjoying the same freely and openly without any interference, objection, interruption of any nature whatsoever from any person whatsoever until the following incidents took place which has caused tremendous disturbance to our peaceful physical possession of our aforesaid land.

In the month of July 2024, said Bigu Munda received a notice from the office of the SDL&LRO, Siliguri in connection with Appeal Case No. 24/XIII/SDL&LRO-Slg/2022 and 25/XIII/SDL&LRO-Slg/2022 wherefrom he came to know that four persons namely- (1) Smt. Jhal Munda @ Jhalo Munda, wife of Late Lepa Munda, resident of Lichu Bagan, Baniakhari, P.O. and P.S. Matigara, District- Darjeeling, PIN-734010, (2) Smt. Ashari Oraon, wife of Gopal Oraon and daughter of Late Lepa Munda, resident of Lichu Bagan, Baniakhari, P.O. and P.S. Matigara, District- Darjeeling, PIN-734010, (3) Smt. Kamini Munda, wife of Arjun Munda and daughter of Late Lepa Munda, resident of Lichu Bagan, Baniakhari, P.O. and P.S. Matigara, District- Darjeeling, PIN-734010, and (4) Sri. Laddu Munda, son of Late Lepa Munda, resident of Lichu Bagan, Baniakhari, P.O. and P.S. Matigara, District- Darjeeling, PIN-734010, falsely claiming that his father had another son namely Lepa Munda and they being the sons and daughters of said Lepa Munda are the legal heirs of his father Parameshwar Munda have sold several parts of the aforesaid land to (1) Sri. Rajesh Oraon by making false and fabricated Sale Deeds being Sale Deed No. 581, 582 and 585 all for the year 2019, and (2) Sri. Jewel Oraon by making false and fabricated Sale Deeds being Sale Deed No. 583 for the year 2019, 584 for the year 2019 and 586 for the year 2019, and subsequently manufactured several deeds of rectification for rectifying such sale deeds.

In support of their false and baseless claims regarding legal heirship, the aforesaid persons have fraudulently manufactured false death certificate of one Parameshwar Munda, son of Late Sule Munda, and false legal heir certificate mentioning the name of Lepa Munda along with the name of Bigu Munda as the legal heirs of said Parameshwar Munda, son of Sule Munda, in active collusion with the local panchayat authorities.

Furthermore, on 06.01.2025, Sri. Rajesh Oraon, Sri. Jewel Oraon, Smt. Jhal Munda @ Jhalo Munda, Smt. Ashari Oraon, Smt. Kamini Munda, and Sri. Laddu Munda, along with their antisocial

associates armed with hammers and crowbars gathered near the aforesaid land with an intention of taking forceful physical possession of the aforesaid land made an attempt to enter into the said land. I being timely informed by one of my well-wishers about the planning of Sri. Rajesh Oraon and Sri. Jewel Oraon and their men and persons, immediately arranged for resistance to their plan with the help of my friends and well-wishers of that locality. Being vividly resisted by me and my friends and well-wishers, Sri. Rajesh Oraon and Sri. Jewel Oraon and their antisocial associates kept their plan in abeyance for the time being and left the place threatening me and my men and persons that they will come again with stronger force, and they will take forcible possession of the suit land at any cost if in the meantime I do not pay them Rs.1,00,00,000/- (Rupees one crore only).

It is to mention here that said Bigu Munda's father Parameshwar Munda son of Late Chhuiya Oraon had no other son or daughter except Bigu Munda and he left no other legal heirs except him at the time of his death as his mother has already died prior to the death of his father.

It is also to mention here that said Rajesh Oraon and Jewel Oraon are notorious land mafias of that locality and they and their associates are involved in organised crime of creating disputes in the landed property by making false and fabricated documents thereof for grabbing such land and for extorting money illegally by threatening the original owners about such disputes and of their nexus with the various authorities and influential persons. In such a situation and from the aforesaid acts and conducts of the aforesaid persons it is quite evident that said Rajesh Oraon and Jewel Oraon in collusion with Smt. Jhal Munda @ Jhalo Munda, Smt. Ashari Oraon, Smt. Kamini Munda and Sri. Laddu Munda, have hatched a deep rooted conspiracy to grab our land and for that purpose have manufactured false death certificate of Parameshwar Munda, son of Sule Munda and legal heir certificate of said Parameshwar Munda in collusion with the local panchayat authority. By such false documents they have impersonated one Lepa Munda as the brother of Bigu Munda and created a false story of co-ownership of Smt. Jhal Munda @ Jhalo Munda, Smt. Ashari Oraon, Smt. Kamini Munda and Sri. Laddu Munda in the said land for their unlawful gain. In furtherance of such conspiracy, they have fraudulently manufactured the aforesaid false Sale Deeds and Deeds of rectification for their unlawful gain.

Under the aforesaid facts and circumstances, I therefore request you to kindly investigate into the aforesaid facts and take appropriate action(s) against all the culprits and the perpetrator of the aforesaid
