Sir,

In producing herewith One (01) accused person namely Suman Roy(28) s/o Rajesh Roy of Shanti Para Fulbari-I PS NJP Dist Jalpaiguri under arrest and 01(one) Improvised iron made small fire arm measuring 24 cm in length with trigger, striking hammer, striking pin in working condition with wooden butt marked as Exhibit A", and One (01) rounds 7.62 mm Live ammunitions marked as Exhibit B.

I, SI, Sk. Tamzid Ali of NJP PS, SPC do hereby lodged this written complaint against the arrested accused person namely Suman Roy(28) s/o Rajesh Roy of Shanti Para Fulbari-I PS NJP Dist Jalpaiguri .


In this regard, I beg to report that today i.e. on 16.01.25 at 11.25 hrs, I received a specific secret information that one person namely Suman Roy had been coming from Tinbatti side towards Njp station area for committing heinous crime under PS- NJP, Dist- Jalpaiguri. Accordingly, I diarized the information in General diary vide NJP PS GDE No 884 dated 16.01.25 and informed the fact to you. As per your kind order and direction myself along with SI Samik Paul ASI Manoj Majumdar C/1462 Sajan Tamang VP 13 Jamirul Islam all of NJP PS left for Tinbatti side under PS- NJP, with investigation kit to work out the information by Govt. vehicle having no WB 77 4092 to verify the veracity of the information. Under such urgent circumstances any search warrant or authorization for search could not be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. At 11.55 hrs we arrived at Khasmir Colony under NJP PS and as indicated by the source we noticed that one person was coming from Tinbatti side. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to apprehended him. On interrogation, he disclosed his identity as noted above. As per our source information, he possessed 01 improvised small Fire arm, hence, immediately we searched the person and recovered 01 improvised iron made small Fire arms measuring 24 cm in length with trigger, striking hammer, striking pin in working condition with wooden butt which was covered by a synthetic bag and kept concealed in the waist under the cover of his shirt and 01 round 7.62 mm live ammunition in his left pocket of full pant. On demand he failed to produce any document in support of the said improvised Fire arm and live ammunitions which was found in his exclusive possession. Thus, their involvement in carrying and possessing illegal Fire arm and ammunition was established, Then I seized the said improvised small Fire arm measuring 24cm in length with trigger, striking hammer, striking pin in working condition with wooden butt marked as "Exhibit A" and one rounds 7.62 mm live ammunitions and marked as "Exhibit-B", under proper seizure list duly signed by the witness namely 1)Firoj Rahaman s/o Azizul Rahaman of Amaldighiu Fulbari PS NJP Dist Jalpaiguri and 2)Nital Sarkar s/o Lt Ganesh Sarkar of Thakurnagar BJP Conoly PS NJP Dist Jalpaiguri and acknowledge by the accused person. The search, seizure and label were made in between 12 05 hrs to 12 30 hrs and subsequently I arrested them by preparing memo of arrest and informing him the ground of arrest

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused persons namely Suman Roy(28) s/o Rajesh Roy of Shanti Para Fulbari-I PS NJP Dist Jalpaiguri is desperate and dangerous in nature, and he is carrying the said Fire arm ammunitions with an ill motive to commit heinous crime in the locality. As he willfully violated the regulation of Arms Act, 1. therefore, pray before your good self that a specific case may kindly be initiated against the accused person namely Suman Roy(28) s/o Rajesh Roy of Shanti Para Fulbari-I PS NJP Dist Jalpaiguri under proper section of law and its investigation may kindly be arranged.
