Sir,

With due respect, In producing herewith one accused person namely Ansarul Haque (26) s/o Setabuddin of Nishit Pur PO Simulia PS Dalkhola Dist Uttar Dinajpur under arrest along with seized cattle and seized vehicle ;

1. Twenty (20) numbers of Buffalo and Twenty three (23) no of Buffalo calves in black color and different size. (Total 43 nos of Buffaloes)
2. One Vehicle (Truck canter) having Registration No. UP 21DT 8716 which was loaded with Buffalo.

I, SI Tanmay Kundu Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused person to the effect that on 16.01.25 at 10-15 hrs received a secret source information that one vehicle being loaded with Buffaloes illegally is coming towards Jalpaiguri side from Phansidewa side without any valid documents/papers and if immediate action is taken, it can be apprehend. Accordingly I shared the information to you and duty officer of PS. Thereafter as per your direction myself along with ASI Manoj Majumdar C/ 1462 Sajan Tamang VP 13 Jamirul Haque VP 08 Laxman Roy left for Jotiakali to verify the veracity of information. At around 10-35 hrs we reached at Joydev Vita , Jotiakali on A.H.-2 in front of JIO Petrol Pump and after some times on the basis of secret information we intercepted one vehicle having No. UP 21 DT 8716 and apprehended the driver of the said vehicle. On checking the vehicle we found Twenty (20) numbers of Buffalo and Twenty three (23) no of Buffaloes calves in black color and different size were loaded on the said vehicle. On being asked the apprehended driver disclosed his name and address mentioned above and admitted that he is the driver of the said vehicle and also stated he is carrying the buffalo in his vehicle from Hajipur, Bihar side towards Assam for selling the same illegally for wrong full gain. On being asked, he failed to produce any License/ papers in support of carrying the said Cattles in that vehicle and also failed to produce any papers/documents in respect of the said Buffalo. It is crystal clear and reason to believe that the above noted accused driver procured the said Buffalo by illegal means or by stolen means for dishonestly to dispose the same to earn huge money illegally. On further checking it was found that there was no arrangement made for food and water for the said Cattles as per Govt. rules. Besides this there was no sufficient space for the Cattles in that vehicle. The apprehended accused driver of vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Twenty (20) numbers of Buffaloes and Twenty three (23) no of Buffalo calves in black color and different size 2. One Vehicle (Truck) having Registration No. UP 21DT 8716 which used to carry the seized Buffalo as per proper seizure list duly sign by the witnesses and arrested the apprehended person u/s 35 BNSS. The seizure and arrest have been made in between 11-25 hrs to 11-55 hrs.

Under the above circumstances, I pray to you that a specific case may kindly be started against the above noted arrested person namely Ansarul Haque (2 s/o Setabuddin of Nishit Pur PO Simulia PS Dalkhola Dist Uttar Dinajpur of the above noted seized vehicle having No. UP 21DT 8716 and arrange for its investigation as per law.
