In producing herewith four (04) arrested accused persons namely 1. Subhash Barman, aged 48 years S/o Lt. Dukhdhan Barman of Gachtala, Gossair Hat, PS Sitalkuchi Dist. Coochbehar 2. Anawar Seikh, aged 24 years S/o kalam Seikh of Bangitala Feild PS Mothabari Dist. Malda 3. Sayem Seikh, aged 23 years S/o Emaul Seikh of Bangitala Feild PS Mothabari Dist. Malda 4. Ms Sumita Barman, aged 45 years W/o Sarat Barman of Gossair Hat PS Sitalkuchi Dist. Coochbehar along with following seized articles viz,

1. One transparent plastic zipper packet wrapped with black colour plastic carry bag containing 300 grams (Three hundred) said to be brown sugar (Heroin) , Marked as Exhibit- A
2. One transparent Zipper plastic packet wrapped with black colour plastic carry bag containing 276 grams (Two hundred seventy Six) said to be brown sugar (Heroin) , Marked as Exhibit- B
2. One Rebel Red Metallic-2 colour Activa 125 Disc. bearing No. WB-74-BF-5136 with key.
3. One Motorola Android Mobile, light green colour from accused Anwar Seikh.
4. One OPPO black colour Android Mobile from accused Sayem Seikh.
5. One Samsung Android Mobile phone light gray colour from accused Ms Sumita Barman.

I, SI Samik Paul of NJP PS, Siliguri Police Commissionerate do hereby lodged this complaint against 1. Subhash Barman, aged 48 years S/o Lt. Dukhdhan Barman of Gachtala, Gossair Hat, PS Sitalkuchi Dist. Coochbehar 2. Anawar Seikh, aged 24 years S/o kalam Seikh of Bangitala Feild PS Mothabari Dist. Malda 3. Sayem Seikh, aged 23 years S/o Emaul Seikh of Bangitala Feild PS Mothabari Dist. Malda 4. Ms Sumita Barman, aged 45 years W/o Sarat Barman of Gossair Hat PS Sitalkuchi Dist. Coochbehar to the effect that on 16.01.25 at about 16-05 hrs I received a secret source of information that three persons were coming with one Scooty bearing No. WB-74-BF-5136 towards Noukaghat side through Medical road from Bagdogra side with huge quantity of brown sugar for clandestinely disposal of the same illegally near Porajhar More. The was diarised vide NJP PS GDE No. 905 dt. 16.01.25. Accordingly I informed the matter to the duty officer and I.C PS and as per his instruction of I.C. PS myself along with SI Tanmay Kundu, ASI Monaj Majumder, C/1462 Sajan Tamang, LC-1328 Sangita Maley, VP-08 Laxman Ray, VP-13 Jamirul Islam with mobile Van officer SI Rana Brahma and force and one videographer left for the spot to verify the veracity of the information vide corresponding NJP PS G.D.E. No. 906 dtd 16.01.25 and NJP PS M.C.C No- 154/25 Dt.16.01.25.

At the time of departure from the Police Station I also brought one spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal, emergency light etc. At about 16:35 hrs, we reached near Porajhar more under NJP PS by Govt. vehicle bearing No. WB-72-B-0007 and met with my source. He briefed me about the detail information and stated that the suspected Scooty will arrive at Porajhar more shortly and dispose the same at that place. I then looked up for public witnesses to witness the entire process of search and seizure and found 02 independent public witnesses namely (i) Samir Majumder (33 yrs) S/o Haripada Majumder of Porajhar more PS NJP, Dist. Jalpaiguri, (M.No. 7477745163) (ii) Subrata mandal (30 yrs) S/o Dayal Mandal of Porajhar More PS NJP Dist. Jalpaiguri M.No. 9733383529. I briefed them about the information we had and requested them verbally to stand as witnesses. They voluntarily agreed to stand as witness during the process of search and seizure and other process thereafter. I also served them notice in accordance with the provisions of law in this regard in writing.

On identified by the source we found that three persons with one Scooty was coming from Medical More side and stop at Porajhar More near one lady person who was standing at the place and we cordoned the said place and intercepted the said Scooty and apprehended three persons and one female person. On being asked they disclosed their identity as noted above which is not verified. I asked them to produce their identity proof documents, but they failed and I introduced myself and the raid team members to the suspected male and female persons as Police personnel. I apprised all the detainees about the information in hand and started to examine them thoroughly and I asked them whether they wanted to be searched themselves and their Scooty in presence of Executive Magistrate or any Gazetted Officer because we have information that you are carrying huge quantity of drugs like brown sugar and they agreed to search by any

one. I also served them option of notice in accordance with the provisions of law in this regard in writing and they also gave their approval of being searched by any one in writing in the notice served to them.

Accordingly I informed the matter to I.C. NJP PS and he informed me over mobile phone to send one requisition to Sri Somnath Das ,ACP, East-II, SPC as he is detailed for special executive magistrate for this date as no other magistrate were available in that time. Accordingly I informed Sri Somnath Das ,ACP, East-II, SPC and requested him to come to the spot through one special messenger namely C/1462 Sajan Tamang at his office at Tinbatti More, Siliguri which was received at 17-50 hrs . At about 18.05 hrs Sri Somnath Das ,ACP, East-II, SPC arrived at the spot and I disclosed the identity of Sri Somnath Das ,ACP, East-II, SPC as a Gazetted officer to the accused persons and also to the witnesses. I also offered the independent witnesses and the accused persons to search our Police Party as per provision of law. After search by the detained persons a Nil search list has been prepared which was duly signed by detained persons, Independent witnesses and members of raiding team.

Under the supervision of Sri Somnath Das ,ACP, East-II, SPC and in presence of independent witnesses I conducted searched of the three male detained persons and Scooty who were coming jointly in the said Scooty and recovered one transparent plastic packet wrapped with black colour plastic carry bag containing said to be brown sugar (Heroin) from the pocket of pant of one of accused Anowar Seikh. Thereafter I searched the lady personal by the Lady constable No. 1328 Sangita Maley in Govt. Police Jeep as there was no any enclosed space, strictly maintaining female modesty and recovered another one transparent plastic packet wrapped with black colour plastic carry bag containing said to be brown sugar (Heroin) from the apprehended lady person. On demand in presence of the Gazetted Officer Sri Somnath Das ,ACP, East-II, SPC the apprehended persons failed to produce any valid documents in support of possessing the same.

I accordingly weighed the recovered two plastic packet containing said to be brown sugar (Heroin) by the weighing instrument (1) One transparent plastic packet in containing 300 grams (One hundred two) said to be brown sugar (Heroin) , Marked as Exhibit- A which was recovered from accused Anowar Seikh (2) One transparent Zipper plastic packet in containing 276 grams (Two hundred seventy Six) said to be brown sugar (Heroin) , Marked as Exhibit- B which was recovered from accused Sumita Barman . Accordingly I seized the same and also seized 1. One Rebel Red Metallic-2 colour Axtiva 125 Disc. bearing No. WB-74-BF-5136 with key 2. One Motorola Android Mobile, light green colour from accused Anwar 3. One OPPO' black colour Android Mobile from accused Sayem Seikh 4. One Samsung Android Mobile phone light gray colour from accused Ms Sumita Barman from their joint possession under proper seizure list and labeled and sealed all the articles in presence of Sri Somnath Das ,ACP, East-II, SPC and independent witnesses and accused persons duly signed by them and the Gazetted officer Sri Somnath Das ,ACP, East-II, SPC and acknowledged by the accused persons. On further asked, the apprehend persons confessed their guilt in presence of Gazetted Officer Sri Somnath Das ,ACP, East-II, SPC and other witnesses that they are known to each other for this business and the three male accused persons jointly procured brown sugar clandestinely from Kaliachak, Malda for the purpose of selling the same through the lady person to their designated customers in order to earn huge money illegally in Siliguri and Jalpaiguri area. Then I arrested the above noted four accused persons u/s- 35 BNSS after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act. The entire search and seizure process have been videographed by videographer Mr. Tapan Mandal who had accompanied the raiding police team. The seizure and arrest was made between 18-15 hrs to 19-15 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against four accused persons namely 1. Subhash Barman, aged 48 years S/o Lt. Dukhdhan Barman of Gachtala, Gossair Hat, PS Sitalkuchi Dist. Coochbehar 2. Anowar Seikh, aged 24 years S/o kalam Seikh of Bangitala Feild PS Mothabari Dist. Malda 3. Sayem Seikh, aged 23 years S/o Emaul Seikh of Bangitala Feild PS Mothabari Dist. Malda 4. Ms Sumita Barman , aged 45 years W/o Sarat Barman of Gossair Hat PS Sitalkuchi Dist. Coochbehar and arrange for its investigation.
