With due respect, In producing herewith one accused person namely Shib Choudhuri (19) @ Munga S/O Subal Choudhuri of vill- Maharaj Colony back side of Bishal Mega Mart, PS- Siliguri, dist- Darjeeling under arrest along with seized bi-cycle ;

I, SI Sk. Tamzid Ali Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused person to the effect that on 18.01.25 at 17:05 hrs received a secret source information that one person is carrying one black color Hero giants bi-cycle by dishonestly and if immediate action is taken, it can be apprehend. Accordingly I shared the information to you and duty officer of PS. Thereafter as per your direction myself along with ASI Manoj Majumdar C/1462 Sajan Tamang VP 13 Jamirul Haque VP 08 Laxman Roy left for Rail Hospital More to verify the veracity of information. At around 17-15 hrs we reached at Rail Hospital More and after some times on the basis of secret information we intercepted the above noted person and also found one black colour Hero giants bi-cycle. On being asked he disclosed that the bi-cycle which he had been cycling was a theft property and he himself had stolen the said cycle. Accordingly without any delay I seized the bi-cycle and arrested the accused person.

On the way to Police station, I further interrogated the said accused person and during interrogation he revealed that not only this cycle, but he had stolen many more cycle from different areas under NJP PS and storage in a abundant railway quarter garage at Kasmir Colony under NJP PS, according with out any delay I along with other officer and force went to Kasmir Colony and seized another ten(10) cycle from the possession and being identified by the above note accused person with presence to other individual witnesses .

Under the above circumstances, I pray to you that a specific case may kindly be started against the above noted arrested person namely Shib Choudhuri (19) @ Munga S/O Subal Choudhuri of vill- Maharaj Colony back side of Bishal Mega Mart, PS- Siliguri, dist- Darjeeling of the above noted seized bi-cycle and arrange for its investigation as per law.
