In producing herewith three arrested accused persons namely 1. Sahajat Budharu of North Bengal Farm, near Battala Bazar, PO-Sikarpur, PS- Rajganj, Dist. Darjeeling (Not Verified) 2. Guddu Yadav (M/24) S/O Lt. Jogender Yadav of Babupara, back side of Rajganj police Station, PS- Rajganj, Dist. Jalpaiguri (Not Verified) and 3. Sankar Mahato (M/38) S/O Sudeb Mahato of Jalpaimore, Natun Para, W/ No.05, SMC PS- Siliguri, Dist. Darjeeling (Not Verified) under arrest along with seized Two Cow's and seized one vehicle as per seizure list.

I, ASI (UB) Amal Roy of NBMC O.P, PS- Matigara Police Station under Siliguri Police Commissionerate do here by lodged a written complaint against three arrested accused persons 1. Sahajat Ali (M/25) S/O Md. Budharu of North Bengal Farm, near Battala Bazar, PO-Sikarpur, PS- Rajganj, Dist. Darjeeling (Not Verified) 2. Guddu Yadav (M/24) S/O Lt. Jogender Yadav of Babupara, back side of Rajganj police Station, PS- Rajganj, Dist. Jalpaiguri (Not Verified) and 3. Sankar Mahato (M/38) S/O Sudeb Mahato of Jalpaimore, Natun Para, W/ No.05, SMC PS- Siliguri, Dist. Darjeeling (Not Verified) to the effect that today on 24.01.2024 at 15.05 Hrs received a specific input from the source that huge numbers of stolen cow's are being transported in one vehicle towards Fulbari through Kawakhali, Bidhanpally road. If the information would not be perused immediately those Cow's would have been concealed by them. Accordingly the fact is informed to O/C NBMC O.P and diarized the matter vide NBMC O.P GD Entry No- 486, Date 24.01.2025 and as per the direction of O/C NBMC O.P myself, along with ASI S.K Sabrati, ASI Bijoy Khaskel, C/1085 Mithun Debnath and CV-158 Partha Sarkar left for Kawakhali, Bidhanpally under Matigara P.S to verify the veracity of the information. At 15.35 hrs we reached at Kawakhali, Bidhanpally and called 2(two) independent witnesses namely (1) Rajiv Mahato S/O Jahahir Mahato of Kawakhali, near Neemtala Ghat, P.O-Sushruta Nagar, PS- Matigara, Dist. Darjeeling and (2) Khokan Das S/O Budhu Das of Kawakhali, near Kawakhali SSK Pny School, PO-Sushruta Nagar, PS- Matigara, Dist-Darjeeling and after disclosing our identity and disclosed the fact I requested them to accompany with us as witnesses. I started waiting at Kawakhali, Bidhanpally area and looking for the said vehicle loaded with Cow's. After few minutes we saw one Cream White Color TATA INTRA V30 wheeler Vehicle bearing Registration No- WB73/G/8756 coming from Ranidanga
