On account this incident not only our workers are feeling unsecured at site but also the progress of work of this time bound project is being hampered & discouraged.

It is therefore kindly requested & pledged that a night patrolling during the aforesaid hours at the concerned location & around may kindly be arranged regularly to discourage the such repeated occurrence to enable us to continue the activity of night shift work in normal way with a feeling of security. Therefore you are requested to kindly to take necessary actions against him and lodge an FIR against the said above fact.
