**Sub: F.I.R. against Binod Chhetri, Dipak Chhetri, both are Son of not known and 18 others, all are resident of Toribari, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri.**

**Respected Sir,**

I, **Vivek Tamang**, Son of Late Bijay Tamang, resident of Salugara, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge an F.I.R. against Binod Chhetri, Dipak Chhetri, both are Son of not known and 18 others, all are resident of Toribari, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effect that on 26-01-2025 at about 7:00 PM at Toribati near Gumba/Buddhist Monastery, said Binod Chhetri; Dipak Chhetri and 18 others with khukri, sickle, iron siklis, axes, bamboos, sticks, iron rods and broken sharp tiles in their hands physically assaulted me, **Dipen Roy, Rakesh Chowdhury, Amit Rathore** and **Abhishek Biswas** and they also set ablaze one two wheeler (KTM DUKE) bearing registration No.WB-74-AL-1283 which burnt into ashes belonging to Karan Chhetri and also smashed and ransacked my four wheeler (Creta Hyundai) bearing registration No.WB-10-7248 and broke the glasses and fully damaged the vehicle.

Due to the aforesaid assault by the above persons, said Dipen Roy, Rakesh Chowdhury and Amit Rathore sustained bleeding injuries on their heads and their persons and I also sustained injuries on my person. They were taken to Siliguri District Hospital and treated therein and also got stitches on their heads respectively.

That the aforesaid persons are very desperate in nature and dangerous persons of the locality and they do not care about the law of the land.

So, therefore, I humbly request your goodself to take stringent legal action against the aforesaid persons and book them as per the provision of law at an earliest.
