With due respect, I am producing herewith the following seized articles viz :- (i) one Thermocol box containing 24 bottles of "TOBORG" premium Beer each bottle containing 650 ml i.e. total $(24 \times 650 \text{ ml}) = 15.600 \text{ ltrs marked as Exhibit "A" out of which one bottle of the same taken as$ sample for examination and marked as Exhibit "A1" and (ii) one Thermocol box containing 24 bottles of "TOBORG" premium Beer each bottle containing 650 ml i.e. total (24 x 650 ml) = 15.600 ltrs marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1". I SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodged this written complaint against accused namely Sakhiya Roy W/O Late Ram Sagar Roy of Rajendra Nagar, Coolipara, Ward No-01, PS-Pradhan Nagar, Dist.- Darjeeling to the effect that on 24.01.25 at 00.05 hrs I received source information that one Sakhiya Roy of Rajendra Nagar, Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling is selling illicit liquor illegally at her residence and she stored huge quantity of illicit liquor at her residence without any valid documents. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No. 1343 dated 24.01.25 and informed the matter you. As per your kind order and direction, I along with SI Rajiv Subba, ASI Prabal Sarkar, LASI Mithu Kabiraj, C/1411 Ashok Roy C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Rajendra Nagar Coolopara under PS- Pradhan Nagar, Dist.-Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. At around 00.15 hrs we arrived at the spot and contact with my source. Then as identified by the source source, I along with other officers and force conducted raid at the residence of said accused Sakhiya Roy of Rajendra Nagar, Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling in presence independent witness but found she is absconding. On search in presence of independent witness and the above mentioned illicit liquor were recovered from her residence which she kept conceal inside the bathroom of her residence. We search every possible places to find out the accused Sakhiya Roy but found absconding. During enquiry it could be learnt that the said Sakhiya Roy W/O Late Ram Sagar Roy of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is running such type of illegal business of selling illicit liquor at her residence without any valid documents for her wrongful gain. As the said Sakhiya Roy W/O Late Ram Sagar Roy of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.-Darjeeling violated the norms of Bengal Excise Act, hence I seized the above noted illicit liquor under proper seizure list in presence of witnesses and brought to the PS for further investigation. The whole process of search and seizure were made under the coverage of video graph in between 00.35 hrs to 01.05 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Sakhiya Roy W/O Late Ram Sagar Roy of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
