Received on 24/01/25 at 04.40 hrs vide PDN P.S. CDE NO. 1350 and is registered PDN P.S. Come NO. 55/25 Dt. 24/01/25 U/S 310(4)(5) of BNS and is endersul to SI Govtam modific for its investigation.

In producing herewith three (03) accused persons namely (i) Robit Das (22 yrs) S/Os of Samar Nagar near Basanti Mandir Champagar 100 Das (22 yrs) S/Os Sakun Das of Samar Nagar, near Basanti Mandir, Champasari, PS- Pradhan Nagar, Dist. Darjeeling (ii) Haradhan Karmakar (32 yrs) S/O Late Bimal Karmakar of Pati Colony, 2 No road, PS- Pradhan Nagar, Dist. Darjeeling (iii) Punil Roy (33 yrs) S/O Anil Roy of Krishnagar Colony, Eastern Bypass, PS- Bhakti Nagar, Dist.- Darjeeling under arrest and the following articles under seizure viz ; (i) One iron made sharp cutting weapon locally called as "Khukuri" measuring 18 inches in length including wooden handle (ii) one iron made sharp cutting weapon locally called as "Hasua" measuring approx 56 cm in length (iii) one iron made hammer measuring approx in length including its wooden handle (iv) one iron made bolt cutter measuring approx length 14 inches in length (v) one iron rod measuring approx 84 cm in length (v) one black and red colour torch light and (vii) one white colour nylon bag. I, SI Rajiv Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted three (03) arrested accused persons and others 06/07 unknown miscreants who involve in this crime to the effect that on 24.01.25 at 01:35 hrs I received a specific source information that about 09/10 miscreants equipped deadly weapons assembled at Circuit House More, Champasari under PS- Pradhan Nagar, Dist. Darjeeling and are taking preparation for committing Dacoity at Baghajatin Colony area.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No 1346 dated 24.01.25 and as per your kind order and direction myself along with ASI Prabal Sarkar, ASI Sajal Das, ASI Biplab Kr Das and force all of Pradhan Nagar PS, SPC left for Circuit House More, Champasari under PS- Pradhan Nagar, Dist.-Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer ASI Sanjib Mukharjee of Pradhan Nagar PS and requested him to come to Circuit House More to accompany with us. At around 02:25 hrs we arrived at Circuit House More and after a while R.T van officer ASI Sanjib Mukharjee arrived there and accompany with us. I shared the information with them and briefed them properly. Then, I contacted with my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I searched for two independent witnesses but due to odd hours of night I could able to manage one independent witness namely Ashish Tamang S/O Late Bal Kumar Tamang of Debidanga, PS- Pradhan Nagar, Dist. Darjeeling and I shared the information with him and requested him to remain present and act as witness if any search and seizure would be made, upon which he agreed.

Thereafter, we proceeded towards place and cordoned the place with due care and cautioned and from a considerable distance we noticed that some persons were assembled in a dark place at near Circuit House More and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted 03 (three) accused persons while 06/07 others unknown miscreants managed to fled away from the spot taking the advantage of darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which was they kept conceal inside a white nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparation for committing Dacoity at Bagha Jatin Colony area and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 04.05 hrs to 04.20 hrs on 24.01.25 at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of their arrest. The whole process of search and seizure were made under the coverage of video graphy and brought all the three (03) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted three (03) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at Bagha Jatin Colony and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of law against may kindly be started against the above noted three (03) arrested accused persons namely (i) Rohit Das (22 yrs) S/O Sakun Das of Samar Nagar, near Basanti Mandir, Champasari, PS- Pradhan Nagar, Dist. Darjeeling (ii) Haradhan Karmakar (32 yrs) S/O Late Bimal Karmakar of Pati Colony, 2 No road, PS- Pradhan Nagar, Dist. Darjeeling (iii) Roy (33 yrs) S/O Anil Roy of Krishnagar Colony, Eastern Bypass, PS- Bhakti Nagar, Dist.- Darjeeling and others 05/06 unknown miscreants and arrange for its investigation.
