In producing herewith the following seized articles under proper seizure list viz: (i) one paper made carton styled as Colour Queen containing 60(sixty) used shots fire crackers, (ii) one paper made carton styled as colour shots containing 30(thirty) used shots fire crackers, (iii) one paper made carton styled as Boomerange containing 18(eighteen) used shots fire crackers, (iv) one paper made carton styled as Tiger Tail containing 7(seven) used shots fire crackers, (v) 03(three) numbers of single used shots styled as Enjoy Supreme fire crackers-

I PSI Tinku Modak of Pradhan Nagar PS do hereby submit this written complaint against the President, Secretary, Treasurer and 05/06 unknown members of Panchanadi Sporting Club to the effect that on 26.01.25 from 13.55 hrs I along with force left to perform evening RT Mobile (K-31 van) duty vide. Pradhan Nagar PS GDE No 1491 dated 26.01.25 and MCC No 248/25 dated 26.01.25. During my duty at 20.05 hrs I received an information from the on-duty officer of Pradhan Nagar PS that the members of Panchanadi Sporting Club were bursting illegal fire crackers at their ground causing huge sound pollution in and around the adjacent area. After receiving such information as per consultation with you I along with force rushed to the spot and found the above noted articles scattered on the ground of Panchanadi Sporting Club. During enquiry it was revealed that Panchanadi Sporting Club organized a Badmintan Tournament from 24.01.25 to 26.01.25 and closing ceremony of the said tournament was scheduled for tonight. After closing ceremony of the said tournament 05/06 unknown members of the said club under the leadership of Club President namely Nim Sherpa Bhutia S/O Late Narbu Sherpa of Agam Singh Nagar, PS- Pradhan Nagar, Dist. Darjeeling, Club Secretary namely Omkar Gurung S/O Pradip Gurung of Agam Singh Nagar, PS- Pradhan Nagar, Dist.-Darjeeling and treasurer namely Sabin Rai of Agam Singh Nagar, PS- Pradhan Nagar, Dist. Darjeeling used bursted good numbers of fire crackers on the ground of Panchanadi Sporting Club without following any safety measures and without taking any permission from appropriate authorities and thereby they violated the guidelines of Hob'ble apex court. There was every possibility of accident due to such a kind of negligence act by the members of Panchanadi Sporting Club under the leadership of President, secretary and treasurer of Panchanadi Sporting Club and others. Both sound and environment pollution took place due to burning of fire crackers and for their negligence act. It should be mentioned here that when I along with force reached to the spot, all the above noted accd persons obstructed us, pushed us physically and fled away from the place. Thereafter, I seized the above noted articles from the ground of Panchanadi Sporting Club under proper seizure list in between 20.45 hrs to 21.40 hrs under the coverage of videography as per norms of BNSS.
