I Supriya Tirkex, ^{10/11 Suloor Tirkex} resident of haldibari tg,
P.O - Birnaguri, P.S - Baharhat ^{Dist. Jalpaiguri} would like to inform you that
I am facing a deep life threat and financial problem.
I am a single mother struggling with a six years
old kid. A person named Sagar Thapa S/O Lt Dinu
Thapa, resident of moraghat tg whom I believed
from the bottom of the heart as he promised
me he will take all my responsibilities as he was
agent he used to send outside peoples of the tg
for work. I came with her him along with my son
in Sidliguri as he will take me to bangalore from there
On 17th January when I came with him and started
staying at Growab Hotel, he started torturing
me mentally and physically, he even assaulted my son too.
He without my notice transferred money from my
mobile to various accounts. I stayed there four
days, I somehow rescued with my son from the
hotel on 21/01/25. During that period he has
stolen my musical pad which costs 35,000 that
was a church property, my atm, adhaar card and
42,000 cash from my account. When I came back
to my home my village people told me he
manipulates peoples mind and sells them outside.
He is a traitor. I need justice or else I have to commit
suicide.

I beg you to help me to recover
my stuffs and punish that trouble person severely.
