Sub: Written Complaint against 1) JAYANTA RAY @ JAYANTA ROY (Husband), Son of Jatin Chandra Ray @ Jatin Roy, 2) JATIN CHANDRA RAY (Father-in-Law), Son of Chidam Chandra Ray 3) HIRANBALA ROY (Mother-in-Law) all are residents of Village - 61 Baripukhuri, Post Office and Police Station - Abhayapuri, District - Bongaigaon, Assam, Pin Code - 763383.

Respected Sir,

In utter dismay and agony I, Smt. Tapasi Das, Daughter of Tapan Das, resident of Dakshin Shanti Nagar, Jabravita, Dabgram, District: Jalpaiguri, Pin Code: 734004 would like to bring this to your kind notice that my marriage was solemnized with Jayanta Roy following the Hindu rituals and customs in Maa Bhuvaneshwari Kali Mandir situated at 1 No. Dabgram Colony, Siliguri on 05.03.2017 and after that we started our conjugal life in a rented house at Jailkhana Road, Raja Ram Mohan Colony, Ward No. 20 under Siliguri Municipal Corporation, Siliguri. That in due course of time after we started our conjugal life it came into my knowledge that the said Jayanta Roy was jobless and moreover he was addicted to consumption of drugs such as Brown Sugar and Heroine. That from the very inception of the marriage he showed his true colours and started pressurizing me to give him money for his addiction and if I would not have given him the same then he used to beat me with fists and blows very mercilessly. Somehow I was trying to continue my marital life and anyhow tried to revive the marital tie that we had but all in vain. That after the intervention of family members, friends and well wishers to control his habit of addiction and physical abuse upon me they suggested to shift us to his father's home in Assam. Finding no other alternative I forced him to leave the rented house and shift to his father's home in April, 2018. Only if I knew that the said initiative taken in good intentions will turn out to be the worst nightmare of my life. That after shifting to my in-law's house my husband started to search for job and his physical abuse also stopped for some time. That after sometime an incident happened that shook my guts that my father-in-law tried to touch me inappropriately. That night I told my husband about the traumatising incident that happened but he paid no heed to that and warned me not to discuss about such incident again with him. That from that day onwards I could see that my father-in-law had started to take bad interest

upon me his intentions and approach changed towards me. That after few months Jayanta Roy got a job and for his job purpose he had to travel out of station and taking advantage of that one night my father-in-law snuck and nestled down in my bed after realising that I ran out of the room and went to my mother-in-law and informed her the same but I realised that she was hand in gloves with my father-in-law and paid no attention to it.

After the said incident I left the house of my in-law's and came to Siliguri with my husband and started doing job. It is pertinent to mention here that during the continuation of our marriage, our marriage was consummated and out of that a baby boy was born on 17.07.2020.

It is to be submitted here that I am engaged with a Self Help Group for women's in and around our locality. That during the time of my pregnancy I used to give money of the said group to Jayanta Roy for depositing it in bank but after I resumed my work I found that he used to steal money from there and did not submit the whole money in the bank which totally amounts upto a tune of Rs. 2,50,000/- which I repaid after resuming my work. The said Jayanta Roy had also procured some loans in my name from Indusind Bank and also have procured gold loan by keeping my stridhan jewellerys in Manappuram Finance Limited. The said loans of Mannapuram Gold Loan and the loan from the Self Help Group is still going on and is borne by me.

That Jayanta Roy had also taken away my scooty being registration no. WB 74 AK 0292 and it is not in knowledge that whether he has sold it or not. Moreover while updating my Ration Card to Digitize it I found that Jayanta Roy using some illegal means has already seeded my Aadhar Number with a Ration Card in Assam, Bongaigaon most illegally and is unlawfully depriving me of my basic human rights.

That few days back when I called him in this regard and enquired he blatantly lied about it and started to abuse me. That on 25.01.2025 he tried to enter into my house and when I resisted he beat me with fists and blows and also have tried to harm our baby who is only four years old.

That I was so much traumatised with the incident that I did not knew how to act upon it and after the intervention of family members and well wishers and with their support I had lodged the said complaint, which explains the delay in lodging the complaint.

That I humbly plead before you to take immediate cognizance of the said matter and take stern legal actions against the abovenamed Jayanta Roy (9134766174 / 8597113159), Jatin Chandra Roy and Hiranbala Roy and initiate necessary proceedings against them for the ends of justice.
