Sir,

In producing herewith 01 (one) accused person namely Khokan Mahanta (26), S/O Late Bablu Mahanta of Dhaknikata, Champasari Anchal, PS. Pradhan Nagar, Dist. Darjeeling under arrest with the following seized articles viz: (i) One (01) improvised iron made fire arms havings 13 cm barrel, 08 Cm iron made butt having firing pin, firing hammer, trigger in working condition (Exhibit "A") and (ii) One (01) round loaded live ammunition (Exhibit "B"). I SI, Bandhan Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the avobe noted arrested accused person to the effect that today i.e. on 28.01.2025 at 20.50 hrs I received a specific secret information that one person have posseced fire arms moving suspiciously at old Pradhan Nagar PS area under PS- Pradhan Nagar, Dist.- Darjeeling.

Accordingly, I informed the fact to you. As per your kind order and direction myself along with ASI Biplab Kr Das, ASI Sajal Das, ASI Jagannath Roy and force left for old Pradhan Nagar PS with investigation kit to verify the veracity of the information by Govt, vehicle vide Pradhan Nagar PS GDE No. 1635 dated 28.01.2025 and M.C.C. No. 276/25 dated 28.01.2025 under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape and on the way I shared the information with the raiding team. On the way to old Pradhan Nagar PS area, I contacted with one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling and requested him to come to old Pradhan Nagar PS with his video camera for the purpose of videography of search and seizure if required. After a while the above mention videographer arrived there and accompany with us. Then, I contacted with my source and as indicated by the source we noticed that one person was moving suspiciously infront of Bhiswadeb Cinema hall under Pradhan Nagar PS, Dist. Darjeeling. Accordingly, we cordoned the place from every possible corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we were be able to apprehend him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. On search I recovered One (01) improvised iron made fire arms havings 13 cm barrel, 08 Cm iron made butt having firing pin, firing hammer, trigger in working condition (Exhibit "A") and one (01) round loaded live ammunition (Exhibit "B") from his exclusive and conscious possession. On demand he failed to produce any document in respect of fire Arm and ammunition which was found in his exclusive and conscious possession. He exclusively possessed one Fire arm and one live ammunition illegally. Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, then I seized the above mentioned articles from his possession in presence of independent witnesses namely (i) Gobardhan Mahanta (28), S/O Indradeb Mahanto of Coolipara, Ward No-01', PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Suraj Roy (28), S/O Rajesh Roy of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under proper seizure list and duly signed by the witness and acknowledge by the accused person. The search seizure and label were made in between 22.30 hrs to 23.20 hrs under videography and subsequently arrested him by preparing memo of arrest informing him about the ground of his arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Khokan Mahanta (26), S/O Late Bablu Mahanta of Dhaknikata, Champasari Anchal, PS. Pradhan Nagar, Dist. Darjeeling is desperate and dangerous in nature, as he was carrying the said Fire arm and live ammunition with an objective to commit heinous crime in the locality.

As he wilfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Khokan Mahanta (26), S/O Late Bablu Mahanta of Dhaknikata, Champasari Anchal, PS. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation.
