- 1) The complainant, Sumi Barman, resident of Kadamtala, Champasari, P.O. Pradhan Nagar, P.S. Pradhan Nagar, Dist. Darjeeling, W.B. 734003, respectfully submits the following complaint for the acts of online harassment and threats committed against her.
- 2) That, the complainant, Smt. Sumi Barman, is a law-abiding and respectable citizen
at the above-mentioned address in Siliguri, District Darjeeling, West Bengal.

- 3) That, the complainant was an active user of social media platforms and, a few months ago, received a friend request on the social media application "Facebook" from the accused, Mr. Sujon Roy, a resident of Nalagola, District Malda, West Bengal..
- 4) That the above named accused person created a fake account along with the contact number and Picture of the complainant and started to upload Photos of the complainant by sharing her personal information publically, without the complainant knowledge.
- 5) That the complainant get to know about these when she was getting calls from different numbers also asked inappropriate questions and falsely portraying the complainant as a call girl / sex worker.
- 6) That, the complainant is a married woman and a mother of two children, and these defamatory acts have caused immense humiliation, severely affecting her mental and emotional well-being and making it difficult for her to interact within her community.
- 7) That, the complainant made multiple attempts to contact the accused, requesting him to remove the offensive content. However, the accused refused to cooperate and further threatened to destroy her reputation. He also harassed the complainant in public by attempting to abduct and intimidate her..
- 8) That after hearing such threats finding no alternative the complainant went to the siliguri cyber crime police station dated: 04/11/2024 as well as before the dated: 30/11/2024 against the accused person for strict action according to law but no such actions were taken against the above named accused person till now.
