Sir,

In producing herewith arrested three accused persons namely (1) Md. Habib (30) s/o Lt Mantaz Ali of vill. Madhur Halla Ps Nageswar Dist. Kurigram (Bangladesh) (2) Md. Shamsher Ali (40) s/o Lt. Sakimuddin. Vill. Dhajjan Ps Tetulia Dist Panchagarh(Bangladesh) and (3) Atirul (40) s/o Azizullah Rahaman Vill. Chaturagach Ps. Tetulia Dist Panchagarh(Bangladesh), along with following seized articles viz,

1. One black colour symphony keypad mobile with sim card from Md. Samser Ali.
2. RS/- 110 Bangladesh currency from Md Habib.
3. One yellow colour wire cutter approx length 01 feet.
4. One hydraulic orange colour wire cutter approx length 1.5 feet.
5. One Bashila ( approx length 1.5 feet with bamboo handle.
6. One Hasua(Sickle) approx length 1 feet iron made.
7. One iron made dragger approx length 1 feet.
8. One iron made chopper approx length 1 feet.
9. One empty Black Diamond Cigarette packet made in Bangladesh.

I, SI Tanmay Kundu of New Jalapiguri PS , Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted three accused persons and others to the effect that on 30.01.25 at about 18-05 hrs, I received a specific source input that some Bangladeshi nationals has taken shelter at the house of one Md. Phojkhutu of Fulbari Rajib nagar area under NJP PS. Subsequently, I informed the matter to you and with your prior permission and being directed, myself along with SI Samik Pul ,SI Sk. Tamzid Ali, ASI Manoj Majumdar, VP 08 Laxman Roy C/ 1462 Sajan Tamang left for Rajib Nagar, Fulbari under New Jalpaiguri PS by Govt. vehicle to verify the veracity of the information. This refers to NJP PS. GDE No 18003 Dt. 30.01.25.

After reaching at Rajib nagar Fulbari and as per shown by the source we cordon the house of Md. Phojkhutu, and found that some person had gathered in the room of the said house. After seeing the police party all of them tried to flee away but somehow we managed to apprehended 03 person. On being asked the said apprehended person disclosed their identity as (1) Md. Habib (30) s/o Lt Mantaz Ali of vill. Madhur Halla Ps Nageswar Dist. Kurigram (Bangladesh) (2) Md. Shamsher Ali (40) s/o Lt. Sakimuddin. Vill. Dhajjan Ps Tetulia Dist Panchagarh(Bangladesh) and (3) Atirul (40) s/o Azizullah Rahaman Vill. Chaturagach Ps. Tetulia Dist Panchagarh(Bangladesh). On further interrogation it could be learned that total 08 Bangladeshi nationals had entered India through Mahananda river side where there is no fence and took shelter in the said house with the help of Bangladeshi broker and one Indian broker namely Jahid and also learned that they had come to smuggle cattles from India to Bangladesh. They all had come in India with some ulterior motive and took shelter in the said house. Thus all of the three person had violated the provision of Indian Foreigners Act.

Hence, I arrested the above noted three accused persons u/s 35 BNSS and seized the above noted articles as per proper seizure list with videography and after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started namely (1) Md. Habib (30) s/o Lt Mantaz Ali of vill. Madhur Halla Ps Nageswar Dist. Kurigram (Bangladesh) (2) Md. Shamsher Ali (40) s/o Lt. Sakimuddin. Vill. Dhajjan Ps Tetulia Dist Panchagarh(Bangladesh) and (3) Atirul (40) s/o Azizullah Rahaman Vill. Chaturagach Ps. Tetulia Dist Panchagarh(Bangladesh) 4) Md. Phojkhutu of Fulbari 5)Jahid and others and arrange for its investigation.
