Dear Sir,

I, Sri Shiw Ratan Nakipuria, Son of Late Phool Chand Nakipuria, resident of Keshav Kunj, Babupara, Sreema Sarani, Siliguri, Post Office - Siliguri Town, Police Station - Siliguri, District - Jalpaiguri, PIN-734004 would like to inform you that I along with Sri Arun Kumar Agarwal, Son of Late Chandgi Ram Agarwal and Sri Ratan Agarwala, Son of Sri Om Prakash Agarwal are owners in possession of total land measuring 29 Katha 7 Chhatak 19 Sq. Ft., appertaining to and forming part of RS Plot No.52, 53 & 53/150, recorded in RS Khatian No.682, within Mouza-Dabgram, Sheet No.4, District-Jalpaiguri, by virtue of 4 separate Deeds.

On 29.01.2025, I got information that some people including some labourers are trying to enter into our aforesaid land. On receipt of the said information I along with Sri Arun Kumar Agarwal and Sri Ratan Agarwala reached at the spot where the land is situated. On reaching there we found that some labourers are trying to break the boundary wall and enter into the land. We thereafter intervened and questioned about their identity and upon whose behest the said persons were deployed there. Immediately, the said persons wrapped up their machinery and tools and they ran away from the spot. The said persons while going from the spot have said that they shall come again and take over the land and no person shall be able to spot them.

I, therefore request you to kindly investigate the matter and book the unknown culprits in accordance with law and ensure that the nature and character of the aforesaid plot of land is not changed in any manner whatsoever and the culprits are identified.
