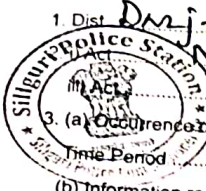

In producing herewith (i) Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Jangipur, Dist.- Murshidabad along with lap baby boy aged approx 1.5 years and (ii) Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling lap baby boy aged approx 02 years (Not verified) and the following seized articles viz.

- a) One transparent Zipper Plastic Pouch containing Total - 322 grams of suspected to be Brown Sugar – seized from the exclusive and conscious possession of Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling and marked as 'Exhibit- A'
- b) One transparent Zipper Plastic Pouch containing Total- 305 grams of suspected to be Brown Sugar – seized from the exclusive and conscious possession of Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Dist.- Murshidabad and marked as 'Exhibit- B'

No. (c) were seized from the exclusive and conscious possession of Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling and Sl. No. (b) & (f) found inside Sl. No. (d) were found from the exclusive and conscious possession of Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Jangipur, Dist.- Murshidabad]

I, SI Newton Biswas of Khalpara TOP-II under Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 02 (two) arrested lady accused persons namely (1) Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Jangipur, Dist.- Murshidabad (2) Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling (Not verified) to the effect that today i.e on 02.02.2025 at about 13.15 hrs. received a specific source information that 02 (two) lady persons were now standing at Govt. Saw Mill Road near Govt. Saw Mill under Siliguri PS possessing huge quantity of narcotic substances Brown Sugar to sell the same to their designed customers. The matter was diarized in Siliguri PS General Diary vide Siliguri PS GDE No. 89 Dated- 02.02.2025 and subsequently, I informed the matter to the Inspector-in-Charge, Siliguri Police Station in written and being directed, myself along with SI Uday Chakraborty, ASI Subir Sen, ASI Jaydeep Dutta, Const-160 Soumen Sarkar, LC/186 Anisha Biswakarma and LC/ 1210 Neelam Chhetri all of Siliguri PS, SPC and along with investigation kit left for Govt. Saw Mill Road near Govt. Saw Mill, Ward No. 04 under Siliguri PS by Govt. aided vehicle having Registration No- WB 72 A 7495, driven by CD-1703 Suchandan Saha to verify the veracity of the source information. This refers to Siliguri PS GDE No. 90 Dated- 02.02.2025 and M.C.C No- 1112/2025 Date-02.02.2025. I also informed cameraman namely Kundan Sah (50) S/O Lt. Jhaman Sah of Vidyasagar Road, Ward No. 07, P.S- Siliguri, Dist.- Darjeeling. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Govt. Saw Mill Road near Govt. Saw Mill under Siliguri Police Station, I contacted two persons namely (1) Niranjana Das (28) S/O Lt. Harihar Das of Ganganagar, Ward No. 05, P.S- Siliguri, Dist.- Darjeeling and (2) Mukesh Mandal (34) S/O Gayna Mandal of Hemanta Basu Colony, Ward No. 04, P.S- Siliguri, Dist.- Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses & cameraman noted above reached at Govt. Saw Mill Road near Govt. Saw Mill under PS Siliguri, Dist.- Darjeeling at 14.15 hrs. and being pointed by the source able to apprehend two lady along with their lap Baby who were standing at Govt. Saw Mill Road near Govt. Saw Mill under PS Siliguri, Dist.- Darjeeling. Each of them were carrying hand bags. Thereafter, we disclosed our identity and informed them regarding the information in hand and stated them that they will be searched in person for the said purpose.

On being asked they disclosed their identity as noted above and admitted that they have illegally possessed Brown Sugar without any valid license for selling the same to their designed customers as per their requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer and they agreed to be searched in presence of any one of the above. As today is holiday and also time period of doing all required process is already overcharged. Hence, I informed the fact to Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station to act as a Gazetted Officer regarding interception of the accused persons suspected to be possessed illegal Brown Sugar and requested him to come at Govt. Saw Mill Road near Govt. Saw Mill under Siliguri PS to remain present and to supervise the search and seizure.

Accordingly, at 14.55 hrs. Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer arrived at the spot Govt. Saw Mill Road near Govt. Saw Mill under Siliguri PS as Gazetted Officer. Then, I offered the independent witnesses and the accused persons to search our police party as per provision of law but they did not search the police party but as per instruction of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer personal search of our raiding party and our vehicles was conducted but nothing incriminating was found. A nil search list to that effect was prepared at 15.05 hrs.

Thereafter in presence Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained lady persons namely (1) Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Jangipur, Dist.- Murshidabad (2) Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling (Not verified) following all formalities, keeping their decency and recovered a) One transparent Zipper Plastic Pouch containing 322 grams of suspected to be Brown Sugar - seized from the exclusive and conscious possession of Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling b) One transparent Zipper Plastic Pouch containing 305 grams of suspected to be Brown Sugar - seized from the exclusive and conscious possession of Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Jangipur, Dist.- Murshidabad c) One grey colour ladies hand bag d) one light purple colour ladies hand bag e) One blue colour Redmi Mobile phone having IMEI 1: 863190051956477/78 & IMEI 2: 863190051956485/78 f) One Sky blue colour narzo mobile phone having IMEI 1: 862875051994194/23 & IMEI 2 : 862875051994186/23

Further, on demand in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses the above noted detained persons failed to produce any valid documents in support of possessing of such contraband.

Being further interrogation, the lady accused persons noted above admitted in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station, acting as Gazetted Officer and the independent witnesses that they have procured the above noted illegal Brown Sugar clandestinely for the purpose of selling the same in high rate to their designed customers for their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of Brown Sugar illegally for last few months for their wrongful gain.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of the above noted lady accused persons at the spot at Govt. Saw Mill Road near Govt. Saw Mill under Siliguri Police Station Dist.- Darjeeling under proper seizure list in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I labeled the seized articles in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer and independent witnesses as noted above. The whole process of seizure and label was made in between 15.10 hrs. to 15.45 hrs. on 02.02.2025. the whole process of Search seizure is under video graphed.

From the above noted facts and seizure of incriminating articles it is quite evident that the lady accused persons namely (1) Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Jangipur, Dist.- Murshidabad (2) Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling (Not verified) are involved in procuring and selling of Brown Sugar illegally contravening the norms of NDPS Act. Then, I arrested the above noted lady accused persons after observing all the formalities and informing the ground of their arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely (1) Mamina Begum (30) w/o Safikul Sk. Of Chaitani, Dakshin Para, P.S- Lalgola, Jangipur, Dist.- Murshidabad (2) Sabana Khatoon (20) W/O Mangal Paswan of Sutki Godown, P.S- Matigara, Dist.- Darjeeling (Not verified) and arrange for its investigation.
