Sir

With due respect and humble submission I ASI Md. Jamal Mia of Matigara P.S. beg to submit that on 03/02/2025 myself along with force were detailed to perform Evening Mobile Patrolling duty i.e. from 14:00 hrs to 22:00 hrs, vide C.C. No. 279/25, Dated 03/02/2025 and GDE No. 126, Dated 03/02/2025. During my said mobile van duty at about 16:40 hrs, I received a secret source information that one Tractor is loading river bed material from river Rakti at Fulbari Patan Ghat, P.S. Matigara, having no document/Royalty in respect of said load. Accordingly I informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to Fulbari Patan Ghat under Matigara P.S. and intercepted one Tractor bearing without number plate with trolley loaded with river bed materials. Seeing the police party the driver/owner of said Dumper fled away from the spot. It may be presumed that the Driver/Owner said dumper procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from anywhere, for their wrongful gain and proceeding to deliver the same to their designated customer. Accordingly I seized the Tractor with Trolley without Number plate, having Chassis Serial No. T053632859KM, Engine SI No. E3724340 loaded with river bed materials, preparing proper Seizure List and brought it to PS Compound. Search and Seizure was made in between 17:05 hrs to 17:25 hrs on 03/02/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver/owner of Tractor with Trolley without Number plate, having Chassis Serial No. T053632859KM, Engine SI No. E3724340 loaded with river bed materials, and arrange for it's investigation.
