Respected Sir,

Most Humbly, I Sri Manish Bari, Son of Sri Manoj Bari, resident of Khalpara , Viveakanand road, ward No-8 of S.M.C, P.O and P.S Siliguri, Dist -Darjeeling do here by lodge this F.I.R before you to the effect stating that my elder brother namely Sonu Nigam Bari, who is residing at, Bhanu nagar, ward no-43 of SMC, with his family consisting his wife and one daughter and he is living separately from us since last 10 years immediately after his marriage. since last few years he has developed a habit of coming to our house late at night and creating chaos in front of our house and when we come out of our house he demands money from us for this and that reason and for the reputation of family we and in particular my father gives him some amount and then he leaves our house. This activity and demand by pressure continued to become more severe and very often in a week after my marriage and now he comes in a drunken state late at night and start creating mental torture upon me as well as upon my father. Just like previous days yesterday on dated-03/02/2025 at about 11 pm my elder brother namely sonu nigam bari came to our house in a very drunken state and started kicking on the gate and pleting stone on the window due to this my window glass got broken as well as shouting bad words in my name. at first my self did not come out of the house feeling that he would go back after few minute of shouting but my thinking was wrong as he state for about 30 minute and their after my father came out of the house to console him so that he returns back but on seeing my father he started shouting in a larger voice spelling bad words and languages in my name so I had to also come out of my house and on seeing me he kicked me badly on my stomach due to which I was forced to sit on the road and on seeing my helpless condition my father came to me to lift me and on seeing this he assaulted my father in front of my eyes and he demanded a sum of rupees 5000/ from me only then he would go back. I denied to give him any amount but then he started creating more disturbance and using objectionable and unparliamentary words implicating me and my father and to save our family reputation I had to bent down to his illegal demand and I gave him rupees 2000 and after receiving this amount he wentback to his house but at the time of going he again stated that rupees-3000/ is due and that he will come again today at night and if I do not give this amount to him then he will make attempt to finished my life.

Due to his such act and activities and illegal demand of money I am very much scared of my life and I reasonably believe that he will definitely come today at late hours of night to take this demand of rupee 3000/ and there is every possibility that I may be killed by him under anger and wrath.

So sir I do here by request you to kindly registered this complaint as FIR and take immediate legal action as per law against my elder brother named sonu nigam bari Resident of Bahnu nagar, under Bhaktinagar Police station, Dist-Jalpaiguri.
