GENERAL DIARY 04 Feb 2025

I resident of Rock-wood Darjeeling complain-
ing you that my brother-in-law, insulted
me and challenged me swinging his
fist in front of the people on 3rd Feb
2025 at around 11:30 to 12:30, P.M. in the
afternoon. On that very day i.e. on 3rd Feb
I went to attain ^{mother's} Suddhi Kriya of my
brother in law's Mr. Neeraj Chhetri at
Salbari Nuthibari. Though I didn't know the
reason why Mr Neeraj Chhetri swung his
fist in front of my face and started
at me "get out of my house", I don't like
you. Even Monika Chhetri too challenged me.

After that me and Neeraj Chhetri main
accused with mobile # 896 9609838163
had lot message conversations. Though
I did not threat his life, nor did he
threat my life. At 11:25 PM suddenly
an unknown lady started threatening
me even using vulgar words scolding
my death parents TERO BAU KO CHIHAN

RANDY KO CHORA. I've a detail recording of mobile conversations between unknown lady and me her number is 8967919465. Immediately followed by unknown man and Manoj Chhetri brother of Neeraj Chhetri. regarding all of them they threatened them. me.

I'm a taxi driver I've to go to Siliguri all the times. my life is at stake. my brother in law had their own problem why did he challenged me? I'm just wondering. none of the family members stop Neeraj and Monika Chhetri.

Because of life threat I went to Siliguri Darjeeling and filed 2EXO FIR. against them. Darjeeling is my home town. xerox copy is with me.

I shall therefore be obliged if you investigate the matter and resolved the issue as soon as possible.
