Dear Sir,

I, Ruchi Singhal Agarwal, Wife of Sri Ayush Agarwal, resident of Uttarayon Township, Block- D, House No.11, Police Station- Matigara, District-Darjeeling would like to state that on 08.02.2025 at about 05:30 p.m. (approx.) while I reached my office namely "ARCH 2050 Studios (a partnership firm)" situated at Opposite Lifeline Hospital above Suraj Enterprise, Police Station- Bhaktinagar, District-Jalpaiguri. While I entered my office one of my office employees namely Rahul Sarkar (89270-26536 / 98325-00617) started to behave in a very unruly manner and stopped me from entering my cabin. When I protested Rahul Sarkar pushed me and when I confronted him he touched me inappropriately. All the employees stood there as mute spectators and none came to my rescue.

I was absolutely shocked and tormented since none came to my rescue. I left my office and went home. When I narrated the entire episode to my family members they supported me to report the incident to the police station.

Be it mentioned here that my husband Mr. Ayush Agarwal is one of the partners of the aforesaid firm. I therefore request you to investigate the matter and book the culprit namely Rahul Sarkar in accordance with the appropriate provisions of criminal law and oblige.
