One 8mtr. PCC Electric Pole has been broken at Hiaderpara, near Market Complex, Siliguri, Ward No. 40, by unknown vehicle at midnight today on 09<sup>th</sup> February, 2025. This has resulted in damage of property of WBSEDCL which includes a 8mtr. PCC Pole, ACSR Conductors, Iron material fittings etc.

As per information gathered from site, one vehicle **absconded** the site after damaging the electric pole at midnight.

The total damage incurred by WBSEDCL is Rs.21,320/-only (Twenty One Thousand Three hundred and twenty only).
