Sir,

I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Subhasish Das, Rishi Aurobinda Road, 2n By-Lane Opp Pradhan Building, Opp-Binoy Mension, Ward No.-12, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 10.02.2025 at about 04.15 p.m. acting on a source information I, along with 1) Sri Bijay Lakra, D.E., S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Subhasish Das and inspected service installation, metering installation of Consumer ID 401934722 in the name of Subhasish Das. During inspection it was found that Subhasish Das is using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 03.08.2023 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 4,529.00 (Rupees four thousand five hundred twenty nine only) including the LPSC of Rs. 1,160.00 (Rupees one thousand one hundred sixty only) till the date of 10.02.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Genus Innovation Ltd., serial no. - G01837999 installed against Con Id. 401934722, seized by preparing a formal seizure list duly signed by witnesses.

As Subhasish Das have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
