Respected Sir,

I Bharati Maan @ Naina Singh, Daughter of Sri. Pappu Maan, resident of D-128 DDA Flat, Sector-4 Rohini, Rohini Sector-7, Police Station Rohini Sector-4, Distr:- South West Delhi, presently residing at Radha Krishna Complex, Ward No. 40, P.S. Bhakti Nagar, Dist:- Jalpaiguri, begs to state as follows:-

1. That I am also known to my friends and family by my nick name i.e. Naina Singh as mentioned above.
2. That I work as a Artist with one girl namely Miss Shivani Kaur @ Miss Simran Kaur who lives opposite to Ulka Mart in Apsara Restaurant Cum Bar and our working hours are 7:30 PM to 12:00 AM.
3. That on 09/02/2025 after completing our working hours the above mentioned Miss. Shivani Kaur, requested and induced me to go out with her for clubbing in the Club Namely "Lever 3" Central Park Building, situated at Sevoke Road, P.S. Bhakti Nagar, Dist:- jalpaiguri.
4. That initially I was not ready to go with her as I was tired after my work and had no energy to for clubbing but after her repeated inducement and emotional statements I finally agreed to go with her and at around 12:10 AM i.e. 10/02/2025 I went with her to "Lever 3" and reached there at 12:20 AM we reached there.
5. That after reaching at "Lever 3" few minutes later boyfriend namely Rana (Mobile No. 74775-25313) (full name not known to me) of Miss Shivani Kaur (Mobile No. 78789-66341) came and we all three started talking with each other but after some talk both Mr. Rana and Miss Shivani Kaur started quarreling with each other and started breaking plates and other stuffs whatever they could find in front of them and after that the bouncer

of the club pushed them out of the club and then they started fighting outside the club and a huge scene was created at around 01:00 to 01:30 AM and the people who were present there started saying me that as she had come with me so I should inter fear in the fight and separate them and handle the situation and after I went to separate them and asked them not to fight the said Miss Shivani Kaur pushed me with force and due to her such forceful push I fell down on the floor and then she became more violent and both her boyfriend Rana and Miss Shivani Kaur started assaulting me with fist and blows and kicks and also assaulted me with a fork on my right eye because of which I sustained Sevier injuries and had to undergo a sugary and received 3 stitches below my eyes on my face they had preplanned to kill me and murder me or make me incompetent so that I cannot work. Even after me denying her to come flatly on her face she repeatedly induced me to come to "Level 3". This was all a part of her and her boyfriend conspiracy to kill me.

6. That thereafter seeing my such situation both of them left from the spot leaving me to die in pain and also in senseless state after this incident my floor manager got the information about my injuries and he came for my rescue me where I was unconscious and took me to the Siliguri District Hospital where I was immediately admitted seeing the blood oozing out.
7. That I could not lodge the FIR in due time as I was under going treatment in Siliguri District Hospital and I saty alone here in siliguri and also got discharge yesterday at around 08:30 PM and was not in a situation to lodge a written complaint.

Sir I kindly request you to take strict and immediate action against against the above mentioned culprits who are having the strong intention to kill me. As I stay in a paying guest I am not finding myself safe from the above mentioned.
