

Subject: F.I.R

Sir,

With due respect and humble submission I SI Mrinal Basunia of Matigara P.S do hereby lodge this written complaint to the effect that today on 16/02/2025 I was deputed to perform special Mobile Van duty along with force, since 19:00 hrs to vide Matigara P.S. C.C. No. 410/2025, Dated 16/02/2025 and Matigara P.S. GDE No. 869, Dated -16/02/2025. At about 20:05 hrs, in course of said mobile van duty I received source information that one Truck is standing at Khaprail Bazar under Matigara PS loaded with river bed material which were procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed at Khaprail Bazar under P.S.- Matigara and found one Tata Dumper bearing Regn. No. WB 73 D- 9614 loaded with river bed materials standing near Khaprail Bazar. On seeing the Police team the driver of the vehicle managed to flee away but somehow we apprehended him. On demand he could not produce any valid documents is support of said river bed materials. It is crystal clear that the driver/owner of the vehicle Tata Dumper bearing Regn. No. WB 73 D-9614 procured the loaded river bed materials from somewhere clandestinely and was preceding to sale the same to their designated customer for their wrongful gain.

Finding no other alternatives, I seized the said vehicle Tata Dumper bearing Regn. No. WB 73 D-9614 loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S and arrested the driver namely Pintu Roy (27), S/O Anil Roy of Goyal Jote, PO-Nemai, PS- Matigara, Dist- Darjeeling. The seizure was made in between 20:45 hrs to 20:55 hrs on 16/02/2025.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized Tata Dumper bearing Regn. No. WB 73 D- 9614 and arrange for its investigation.
