Darjeeling, would like to hereby lodge this written complaint to the effect that I being the Director of the company namely Tista Decocem Pvt. Ltd that as a Director of the said company I am entrusted with the duty to look after the well-being of the Company and conduct the day to day transactions and as such I am authorized to give purchase order on behalf of the Company. That in furtherance to the above mentioned authorization I gave orders for certain goods which are the part and parcel of "Rotary Dryer" and such items are as follows (i.e., 7 items in total):
- 1. Rotary Dryer-7.5 meter,
- 2. 6" Pipe 2 Pcs,
- 3. 4"Pipe 1Pcs,
- 4. 14Pcs Flange,
- 5. 9 Pcs Bend,
- 6. 2 Pcs Cyclone,
- 7. 1 Pcs Panel Board.

From Unite Corporation & Resources, being GSTIN/UIN: 19AAEFU0172H2Z5. 136, Netaji Road, Khagra, Beehumpore, Near State Bank of India, Murshidabad. and the value of the said order amounts to Rs. 8,55,500/- (Rupees Eight Lakh Fifty-Five Thousand Ashel Laner.

Five Hundred Only) and the said amount is paid duly and the tax invoice is annexed herewith in this written complaint.

Thereafter the transporter namely South North Roadways (P) Ltd. Having its circle office at Mittal complex, Opp. Of Anandlok Hospital, Sevoke Road, Siliguri-734001, P.S. Bhaktinagar, was engaged to transport the above said items from Netaji Road, Berhampore, Murshidabad, West Bengal, Pin- 742103 to Near Upkar Medical store Punjabi Para, 734001 in furtherance to such it was agreed between me and the transporter that for the service of transportation an amount of Rs. 47,000/- (Rupees Forty Seven Thousand Only) will be charged as consideration and the said amount will be paid after deliver of the equipment at our factory at jotiyakali PO-Fullbari. That later on the supplier confirmed me that the said items were picked up by the aforesaid transporter on 04.01.2025 from the place of dispatch as mentioned above in furtherance to which a proper e-waybill was generated on 04.01.2025 being Ewaybill No. 861484389870 by the supplier in accordance with the proper rule and the same was valid till 06.01.2025. and it was decided that the said consignment shall be delivered to me by 06.01.2025. But the same was not delivered to me on time and till date the transporter had not yet delivered the items to me. Thereafter I tried to contact the transporter but the same was denied and after various positive attempt I could contact one of the office bearer namely Ajit whereupon he told me that the said items were on transportation and again after few days when Icontacted him he said me that the items were under their possession and they further demanding certain additional lump sum amount for releasing the items as mentioned. That the said transporter fraudulently and dishonestly conceals the property and deceived me and the company for their wrongful gain.

They even threatened me with dire consequences and that they shall put my life to an end if I take any legal course against them.
