Respected Sir,

With due respect I Smt. Guddi Thakur, wife of Ramesh Thakur residing at Dabidanga Bazar, under Champasari Gram Panchayat, Police Station – Pradhan Nagar, District – Darjeeling, in the State of West Bengal, would like to lodge this written complaint before you on the following facts and circumstances:

That on 30.11.20208 I got marriage with my husband out of the over affaire. That due to the marriage my family members cut off all kinds of social relation with me but being a faithful wife each and every part of our matrimonial relation I have perform my duty as a wife toward s of my husband and his family members. that on 18.08.2011 One female child namely – Aksha Thakur And on 22.03.2015 a male child namely – Anmol Thakur Born out of the matrimonial relation.

That since the time of marriage I notice my husband is not ready to work with various plea and to maintain the family he is dependent upon the ancestral properties.

That he is always taking financial help from is old aged mother which is not acceptable for me. That the situation become more worst after the birth of our children, when the family responsibility increase. That at present my daughter is aged about 14 Years and continue with her schooling Magrate School and son is aged about 9 years continues his schooling BSF School Kendriy Vidyalaya at salugara.

That since the last two years an extra ordinary change taken place in the attitude of my husband, that I have notice my husband used to blaming over my character to avoid his family responsibility, whenever I have requested him to work to maintain and fulfill the family responsibility, he try to avoid he same by imposing allegation over my character.

That few days ago I have noticed a surprising fact, that my husband used to communicate with other male persons through social media apps as a woman by misusing my identity and photographs.

That I am succedent to take some photo of said conversation of my husband by mis using my identity with other male persons. It is pertinent to mention here my husband used to demand for financial favor from the said male persons by misusing my identity. That this inhumane act of my husband is the gross violation of my matrimonial rights and individual dignity. That my husband used my identity as a commodity for his benefit which is totally immoral in nature.

That when I raise this issue before my husband and his family members, Sunita Singh and my husband denied to answer the same and imposed allegation over me that I am try to kill my husband by serving him "Dhatura seed". That with this allegation my husband with a support of his family members stop to provide ration/ foods to me and started to take own fooding at the house of his sister namely Nimit Singh.

That from the last ten days I am in a starving situation with my minor daughter without proper food. It is quite unbearable for me to see my minor daughter in starvation. that my husband at present left me and my minor daughter and taking every step which can enforce me to finish my life along with my minor daughter. That from the last two-month education of my children are also disturb due to the mal- acts of my husband and his family members.
