Sir,

In producing herewith one seized Dumper vehicle (12 wheeler) having display no WB 45/6355 loaded with river bed materials, I, ASI SK. Tinku of Bhorer Alo PS /SPC do hereby lodged this written complaint against the driver of the 12 (Twelve) wheeler vehicle (Dumper) having display no. WB 45/6355 to the effect that on 17.02.2025 at 00:25 hrs in course of naka checking duty along with force vide MCC No. 333 dtd. 16.02.2025 I received source information that one vehicle bearing Reg. No. WB 45/6355 loaded with river bed materials (sand) is coming from Gander more towards Sahudangi Road under Bhorer Alo PS. The matter was informed to Officer In-charge of Bhorer Alo PS and as per his instruction I along with force left towards Sahudangi Road to work out the information. At about 00.35 hours we reached at Nawapara more and found one vehicle bearing Reg. No. WB 45/6355 with loaded river bed materials was proceeding towards Gander more to Sahudangi Road. I signaled to stop the vehicle but the driver of the said vehicle stopped the vehicle at some distance and fled away from the spot. We searched at nearby places but unable to trace him out. Subsequently, I brought the above noted vehicle at Bhorer Alo Police Station compound, seized the same under proper seizer list.

Under the above circumstances, I pray your good office to start a specific case against driver of the above noted vehicle, bearing No- WB- 45/6355 under proper section of law and arrange for its investigation.
