I Sita Thapa, S/O. Late Dipak Thapa, R/O. Sivitar Tea Estate, Mahandi Tea Garden, P.S. Kurseong, Mahandi, Dist. Darjeeling, Pin - 734203, West Bengal, do hereby state as follows:-

① That one person namely Bijay Pradhan R/O. Shantigram, Nepania Busty, Belgachi, P.O. Belgachi, Dist. Darjeeling Pin - 734423, West Bengal is/was my friend and only for friendship relationship this all-edges person asked me for some money and I was agreed to pay money to that all-edges person only for our friendship relationship for his business purpose.

② That ultimately I had arranged some money as per requirement of the said all-edges person and pay a sum of Rs. 1,60,000 (one lac Sixty thousand) totalling in which Rs. 13,000 in the mode of online and Rs. 1,47,000 in the mode of cash in different dates, (12/12/23 - 5000, 2/1/24 - 1000, 31/12/23 - 1000, 2/1/24 - 1000, 10/2/24 - 400, 27/2/24 - 500, 6/3/24 - 1,19,000)

- ③ That- remaining cash amount-also paid on the above noted dates to the said alleged person.
- ④ That- on 29/01/2025 I called upon him (the said alleged person) and asked him to return the said borrow money from the said alleged person for my urgent need of money and he assured me that he will come on the very next day to my home (address as stated above) and return my all money to me.
- ⑤ That ultimately on 30/01/2025 the said alleged person had come to my home and told me that- He had not avenged the full borrow amount and within the next month he can avenged the total amount- and also told me that- please you come on 12/02/2025 in siliguri at OYO Hotel situated at Metnibari, under Pradhan Nagar police station and I (alleged person) shall pay full amount to you.
- ⑥ That thereafter on 12/02/2025 at early I went before that OYO Hotel, situated at Metnibari, under Pradhan Nagar and the said alleged person requested to sit in his room in the bed and suddenly he slapped me and physically assaulted me and touched my breast and nipple

and molest me and attempt to rape me and threatened me that if I not ready to do sex with him then he murdered me. thereafter anyhow I save my life from that Hotel room and that time I am totally physically unfit, He also threaten me that if I inform to anybody then he murdered me and zited my home.

thereafter I went before S. Cignri District Hospital on the very said date and at present I am under the medical treatment.

Therefore, if is heard that before you please take a necessary strong step against the said alleged person namely Biyay Pradhan (m - 9079941208 / 9711481998) and arrest him and recover the said borrow amount of Rs. 1,60,000 from the said alleged person and registered a specific case against him for punished. Wm for administration & Justice.
