Yunus resident of Tunal para main road ward no-4 of SMC, under Siliguri police station In The Year 2022 At Siliguri after some times I came to know that he was a jobless person and doing not any type of job, but due to my family reputation I did not said that all thing to my parents regarding this issue next year in 2023 I gave birth a baby boy, but after my pregnancy delivery he pressurized upon me to take money from my father and brother after that I brother take a loan of Rs.1,00,000/ (one lac) and give him money for purchase a toto e rickshaw but after some days he again pressurized me to take money from my parents when I refused to take money from my parents then he abusing and started physical assaulting me and his family members support him, many times he came in intoxicated situation and started sexual harassment upon me he try to forcefully physically intimate with me, now ago some days dated-10/01/2025 he again pressurized me to take money from my parents and I reuse it then he along with his family members namely 1. Anwari khatun 2.Roshan khatun 3.Jashmin khatun they all together started assaulting me in physically all the sister-in laws are threaten me that if I could not bring money from my parental house then they will out from the house as well as my husband said that he give me divorce lastly they did not give me food in this situation I left my matrimonial house and came to my parental house, my parents go to their house for requesting them but they all insulting my father and brother.

So I requested to you that please takes some strict action against them. I am highly obliged with you.
