With due respect, I Smt. Putul Ghosh, wife of Late Subal Ghosh, presently residing at AJC Bose Road, Khelaghar More, Hakimpara, Ward No.17 under S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, beg to inform you that I and my son Sri Biswajit Ghosh are residing in a residential house consisting of three rooms, one kitchen and one toilet and bathroom in the above mentioned address since last 18 years. In the said house my sister **Smt. Sikha Ghosh** is also residing but in a separate mess. Since last few month said Sikha Ghosh along with her 2 brother-in-law, namely **Kutty Ghosh** and **Mona Ghosh**, both are son of Amulya Ghosh of Milanpara, Raiganj are trying to oust me from my above mentioned house. That on 14.01.2025 said Sikha Ghosh along with Kutty Ghosh and Mona Ghosh came to my room at about 9.30 a.m. and threatened me to leave the house. Thereafter when I raised protest, said 3 persons assaulted me by fist and blow and also touched my different parts of body with an indecent manner. Thereafter said Kutty Ghosh and Mona Ghosh hold me very tightly but when I tried to escape from them said Kutty Ghosh tore my cloths and thereby outraged my modesty.

So, I request you to take necessary legal action against the above-named persons and obliged there by.
