I, Smt. Tarana Khatoon, wife of Md. Alamgir, resident of  
Dangipara, railway line, Siliguri. P.O - Siliguri, District - Darjeeling, 734002  
West Bengal, would kindly bring to your notice that my husband, Md. Alamgir  
S/O Md. Jafiz, 2) Md. Jafiz, son of Md. Hafiz (father-in-law),  
3) Nikhat Begum w/o Md. Jafiz (mother-in-law), 4) Md. Nandu (Brother-in-law)  
5) Sultana Khatun (sister-in-law), 6) Roksan Begum (sister-in-law),  
7) Fariyana Begum (sister-in-law) all residents of koibdipar, ward no.  
VII P.O - Siliguri, District - Darjeeling, west Bengal have been  
continuously torturing me and harassing me by frequently visiting  
at my parents place where I reside ~~by~~ with dangerous weapon  
like axe, and throws stone at night around 1:30 hrs.  
endangering my life and my son's life including my parents  
Further I have been married to said Md. Alamgir  
since 18.10.22 and immediately after the said marriage I was  
frustrated physically, mentally and emotionally so much that has  
cause a mental retardation to me and my family. All the  
person mentioned above mostly the sister-in-law use to not give  
food to me and has always used filthy language for getting  
money from my parents, everytime and again by demanding  
R.S 500 from my parents. On 18.12.2022 I was  
brutally physically abused by my husband and my in-laws  
and thrown out of the house since that day  
I have been living with my parents  
at Dangipara Siliguri.

Since, that day i.e. on 18.12.22 I was with a child and my husband and in-laws have been torturing me and have not provided me the basic amenities to my child (son born out of the said wedlock)

Even after throwing me out of his house my husband on 18.02.25 along with the in-laws trespassed my parents premises where I stay and started throwing stones and with the dangerous weapons in their hands like axe, telwar etc and threatening me of murdering me and my child including my parents.

Therefore I am in an immediate need of a police protection otherwise my life and my child's life will be in danger as I might be men killed by them. I have been tortured, physically, mentally and financially throughout this marriage and I have been struggling for the finances for myself and the child (son <sup>out</sup> of the said wedlock).

Hence, I would be obliged if this matter is taken into consideration by you as early as possible otherwise my life and my child's life will be in danger including my family.
