Sir,

I, Dolo Roy Barman, Son of Late Rupkanta Roy Barman resident of Salugara, Post Office- Salugara, Police Station- Bhaktinagar, District- Jalpaiguri, Pin No- 734008 lodging this F.I.R on the following effect -

1. That, I have filed one Title Suit being Number T.S No- 570/2024 before the court of Learned Civil Judge Junior Division at Jalpaiguri, against (1) Sri, Subhankar Narayan Bose son of S.N Bose resident of Khudiram pally, P.O- Siliguri & P.s- Siliguri, District -Darjeeling, Pin- 734001. And (2) SN Bose and Company having it's office at Hill Cart Road, Siliguri, P.O- Siliguri & P.s- Siliguri, District -Darjeeling, Pin- 734001, regarding a land measuring 2.06 acre recorded in L.R khatian No. 1524 comprised in L.R Plot No. 68, Mouza - Dabgram, J.L No.2, Sheet No. 4, District- Jalpaiguri, P.S Bhaktinagar, and at present pending for adjudication.
2. That, on 04/10/2024 after perusing all the original documents and taking necessary hearing the Ld. Court was pleased consider the application under order 39 Rule 1 & 2 and directed both the parties to the suit to maintain status quo over the suit property mand not to change the nature and character over the suit property and also directed not to create third party interest over the same and the order is still in force till 30/04/2025 .

3. That, on 06/11/24 both of the defendants have appeared in the said case by filing a Vakalatnama .
4. That it is pertinent to mention here in the meantime the defendants have violated the order of the learned court by trying to construct a well and they are trying to change the nature and character of the suit premises.
5. That whenever I have protested against these misdeeds of the defendants they have threatened me with dire consequence and they have also said that, If I protest against their misdeeds they will kill me and my family. They have further said that they will not obey the order of the Ld. court.
6. That on 17/02/2025 all on a sudden the above named persons came to below schedule landed property and tried to construct a well over the suit property quite violating the order of the Ld. Court and when I raised objection against the said illegal act of the above named person they have threatened me.

Therefore I pray before you to look into this matter in issue and take necessary legal action to protect my right over the suit property and order of the Ld. Court.
