I, Sri. **MANTU DEY**, (being Aadhaar Card No. 8109 7217 3402), Son of Sadhan Chandra Dey, aged about 53 years, Indian by nationality, permanent resident of Jyoti Nagar, I.T.I. Road, P.S. Bhaktinagar, P.O. Sevoke Road, Dist. - Jalpaiguri, Pin-734001 (W.B.).

I would like to inform you about the one incident which occur on 18/02/2025 at about between 6:00 P.M. to 7:00 P.M., when I along with my family members was in my home some of the antisocial girl namely 1) Nutan Pasawan, resident of Ghugni More 2) Kajal Khan, resident of Dangi Para 3) Riya Sarkar, resident of Aashigarh, and another girl whose name is also namely Kajol, resident of Isckon Mandir Anchal Road, came and entered in to my house without any reason and start fighting with my wife Namita Dey and my minor daughter Nandini Dey and when I request them not to do so they started to threatening me with dire consequences that we burn my house with fire and beaten me brutally with belt, Iron Rod, Batam etc. stated that they are the "inside my dwelling house and taken one Gold Chain of 5 Grams and Cash R.s. 20,000/- (rupees Twenty Thousand) only from inside my house.

Further it is pertinent to mentioned that they (above mentioned miscreants) also brings some other antisocial peoples/miscreants who are outside of my dwelling house namely **Sohail Khan, Guddu Paswan**, both of them brutally beaten in private parts of my minor daughter and Outrage modesty of my Minor daughter namely Nandini Dey (aged about 16 years) and with full intention to kill me along with my all family members,

finding no other alternative my son Rahul Dey call to Police toll free No. 100, and shared our location through his phone number vide 8918989877.

Further when Police official reached there all of the above miscreants run away from there and any how I along with my family members save our lives and due to this incident I took

In such circumstances, finding no other alternative I come before you with this present complaint and request you to take necessary action in respect of the above matter as per law and to help me to get justice.
