Subject: Urgent Complaint Regarding Criminal Trespass, Assault, and Death Threats
Respected Sir,

I, Sourav Mitra, a resident of C/o - Barun Mitra, Ramghat road, Near Jalpalmore (B.B.D statue), p.o - Siliguri Bazaar, dist - Darjeeling, pin - 734005, Mob 9475525501 am filling this complaint regarding a violent attack that took place at my residence on 19.02.2025.

On the said date, a person named Madhu (real name unknown) a hotel owner and his nephew, who reside in Siliguri (opposite Paramount Hospital, Khalpara), came to our home and demanded that we provide decoration services for their event. My father, Sri Barun Mitra, refused their request because three years ago, we had set up a pandal for another event of theirs, for which they never paid us due amount of Rs. 9,000/-.

Upon hearing our refusal, they threatened us, saying that if we ever asked for our rightful payment again, they would kill us by sending their hooligans. They also tried to force us into providing the pandal services without payment. When we refused again, they called 8-9 hooligans armed with TMT steel bars and attacked our family, including my father, Sri Barun Mitra, my mother, Smt. Kasturi Mitra, my aunt, Ms. Baby Mitra (a very senior citizen), and our ex-neighbour, Phoolmati Das.

During the attack, my mother and aunt sustained severe injuries due to blows from the steel bars. Our neighbours came to our rescue, and after some resistance, the attackers fled. However, before leaving, they threatened to return within two days to kill us.

Additionally, my 2-year-old son, Souransh Mitra, has been hospitalized for three days due to severe illness, which is why we could not file the complaint immediately. We are living in constant fear of another attack.

I urgently request you to register an FIR against the accused under relevant sections of the IPC. Please ensure strict legal action is taken and provide protection for my family.

Please acknowledge this complaint and take necessary action at the earliest.
