Darjeeling and ii)Sanjay Rajbanshi(24) S/O Chimanta Rajbanshi of Natun Bazar, South Palash, Champasari, P.S Pradhan Nagar, Dist. Darjeeling under arrest along with the following seized articles viz :-(i) One brown colour four wheeler "TATA ACE GOLD" model vehicle having reg. No. WB/73/G/9053, loaded with river bed materials.

I, SI Bhiswadeb Barman of Pradhannagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver, labour and owner of the above mentioned seized vehicles having registration No .WB/73/G/9053 to the effect that on today (19.02.2025) during my RT mobile van duty vide MCC No. 333 dated 19.02.25 vide GDE No 1082 dated 19.02.2025 at around 12.25 hrs. I received a specific source information that illegal mining of river beds materials is going on at Mahananda river bed near military ghat, natun bazar, under Pradhannagar Police Station, Dist. Darjeeling and they will deliver their river bed materials at Chamapasari bazar for illegal gain. Accordingly, I informed the matter to you and as per your kind order and direction myself along with force proceed towards Debidanga Bazar, to verify the veracity of the information by Govt. Vehicle.

On the way at around 12.55 hrs near Ada Ghat more we noticed that one brown colour four wheeler "TATA ACE GOLD" model vehicle having Reg. No. WB/73/G/9053, loaded with river bed materials came towards Champasari bazaar and I stopped the vehicle and physically verified the information, during verification it is found that the driver and one labour of the above noted vehicles were possessing the river bed materials in their vehicles. On demand the said detained persons failed to produce any valid documents/papers for selling such river bed materials. During interrogation the detained persons admitted that they will deliver the river bed materials to their design customers for their wrongful gain since long. Accordingly, I seized the above mentioned vehicles loaded with illegal river bed materials under proper seizure list from the spot and arrested them stating their ground of arrest after following all formalities. The entire process of seizure was made under the coverage of videography in between 13.10 hrs to 13.17 hrs as per norms of BNSS and brought to Pradhan Nagar PS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the owner and arrested driver and labour namely i) Sourav Roy (19) S/O Atul Roy of Natun Bazar, Samar Nagar, Champasari , PS-Pradhan Nagar, Dist. Darjeeling and ii)Sanjay Rajbanshi(24) S/O Chimanta Rajbanshi of Natun Bazar, South Palash, Champasari, P.S Pradhan Nagar, Dist. Darjeeling of the vehicle number (WB/73/G/9053 and arrange for its investigation.
